Program 1) Voter Registration - Blueprint NC engaged in a robust voter registration effort in preparation for the 2021 municipal elections held all across North Carolina, particularly focusing on Latinx voters. Throughout 2021 Blueprint NC sought to make a more concerted effort to better support organizations who are engaged in Latinx civic engagement work around the state. The efforts helped reach the estimated 258,000+ eligible but unregistered Latinx North Carolinians.

4b (Code:) (Expenses \$ 368,650 including grants of \$) (Revenue \$ 232,001)

Despite being an off-year election cycle, Blueprint NC and its partners made significant strides in voter mobilization and outreach during the 2021 municipal races. By supporting a diverse coalition of BPNC partners, we were able to help implement a multi-pronged approach to reach different constituencies of voters who have varying participation levels in the democratic process. In sum, thirteen Blueprint NC partners made 538,120 voter contact attempts. Out of these attempts, we were able to have 63,528 conversations with voters across the state. Furthermore, seven BPNC partners collected 13,617 voter registration applications throughout 2021. Lastly, fifteen BPNC partners organized voter mobilization events at approximately 20 locations statewide.

In 2020, BPNC and our partners learned more about how we can do movement building around issues like climate justice and make investments in political education and leadership development in earnest. Civic engagement needs to be year-round and community-focused, relying on our partners to bring forth the issues that impact their daily lives. In 2021, we emphasized the importance of sustained investment to make the long-lasting change we hope to have in the communities to which we are accountable. Supporting year-round engagement, sustainability and engaging those left out of the process will make a significant difference in expanding the electorate and making us a safer, healthier and more equitable North Carolina.

Blueprint North Carolina plays an important part as a convener of organizations in our state. Blueprint NC partners represent a diverse portfolio of organizations, not only in terms of their advocacy, but also with regards to size and scope. Many groups find themselves at different stages of their organizational life-cycle, especially when compared to others. Some partners we work with are formally incorporated 501(c)(3) organizations, while others rely upon Blueprint for fiscal sponsorship. Some have annual operating budgets in the five-digit range, while others may exceed \$1 million or more.
