Facts And Circumstances Test

Current Year Facts and Circumstances: Treas. Reg. Section 1. 170A-9 (f) (3) (iii) (B) . The Palm Center has raised funds from a broad array of sources over the past five years including numerous foundation grants and dozens of small donors. In 2019 alone, we applied for and received funds from 8 foundations. Based on 20 years of operations (partially as a university research institute and then later as a 501 (c) (3)), we have found that foundation support is more available than support from small donor supporters. However, we do seek gifts from small donors, and we are proud that our donations from private individuals (giving mostly small gifts) increased from \$4,074 in 2017 up to \$9,103 in 2019. We work with Mida & Associates (a philanthropy consultant) to help us raise funds. It is noted that that the public support test improved materially in 2019 to 27.09% from 14.52% in 2018. Treas. Reg. Section 1.170A-9(f)(3)(iii)(D)(2). Palm's public engagement has beenrobust for 20 years, and consists, for the most part, of releasing reports, policymemos, and media statements and providing research to Democratic and Republican Congressional offices. In 2019, we released four policy memos, and 36 press releases. In addition, we released a statement by 41 retired General and Flag Officers and another statement by three former Service Secretaries. Our work was covered widely in the media including stories in Buzzfeed, Washington Post, The Hill, MSNBC News, Politico, and elsewhere. In the five-year period under consideration (2015-2019) we met with more than 50 Pentagon officials and policy analysts, made several visits to Service Academies, and held three Congressional briefings to discuss our research. All of the previous demonstrate that Palm Center is a publically supported Organization with the goal to continue to expand and diversify its donor base and contributed income.
