Current Year Facts and Circumstances: Treas. Reg. Section 1. 170A-9 (f) (3) (iii) (B). Since our founding more than 20 years ago, the Palm Center has received the vast majority of our support from foundations. Similarly, over the five-year span between 2016-2020, we received most of our support from foundations, including 17 grants from 8 different foundations during that time, with grants ranging in size from as low as \$10,000 to a high of \$675,000, with approximately half of the 17 grants in the \$40,000-\$50,000 range. As well, we hired a fundraising consultant for approximately half of this period, held fundraising events, and did direct email outreach to small donors, and as a result, we received dozens of small gifts from individual donors between 2016 and 2020. Moving forward, our goal is to significantly increase our support from small donors, with a goal of raising \$125,000 from them in 2021-2022. (Thus far in 2021, we have raised approximately \$20,000 from 15 small donors. To attract such donors, we are doing extensive direct outreach including e-mail outreach and planning to hold virtual fundraising events. In addition, a foundation notified us that they will provide up to \$250,000 in matching funds over the next 12 months. We have already secured approximately half of that amount in matching commitments from other donors and will work hard to find the rest of the match over the coming months. Treas. Reg. Section 1.170A-9(f)(3)(iii)(D)(2). Palm Center's public engagement has been robust for 20+ years, and consists, for the most part, of releasing reports, policy memos, and media statements and providing research to Democratic and Republican Congressional offices. Over the past 5 years, we released 19 policy memos, 6 research reports, and 108 press releases. Our work has been covered widely in the media including stories in Buzzfeed, Washington Post, The Hill, MSNBC News, Politico, and elsewhere. In the five-year period under consideration (2016-2020) we met with Pentagon officials, made several visits to Service Academies, and held Congressional briefings to discuss our research. All of the previous demonstrate that Palm Center is a publically supported Organization with the goal to continue to expand and diversify its donor base and contributed income.
