Facts And Circumstances Test	
Current Year Facts and Circumstances: Treas. Reg. Section 1. 170A-9 (f) (3) (iii) (B). Since our founding more than 20 years ago, the Palm Center has received the vast majority of our support from foundations. Similarly, over the five-year span between 2017-2021, we received most of our support from foundations, including 20 grants from 8 different foundations during that time, with grants ranging in size from as low as \$10,000 to a high of \$675,000, with approximately half of the 20 grants in the \$10,000-\$50,000 range. The Organization increased efforts in 2021 to diversify contributions from small to medium size donors through direct contact by the Executive Director and Board Members to prior donors, email outreach and virtual events. The organization had a fundraising consultant for approximately eight months during the year. In addition, a foundation provided a matching grant of up to \$250,000 in Q4 2021. All of the prior strategies along with the matching grant assisted the organization with an increase in donors (from \$5 to \$5,000) through direct individual contributions, corporate contributions and through donor advised funds. The matching grant was full-earned during 2021 and 2022.Despite the previous efforts, contributed revenue continued to decrease and were not sufficient to sustain the organization. The Executive Director and Board decided to begin the process to wind down operations during the year with an intent to dissolve the Organization by the end of 2022. Treas. Reg. Section 1.170A-9(f)(3)(iii)(D)(2). Palm Center's public engagement has been robust for 20+ years, and consists, for the most part, of releasing reports, policy memos, and media statements and providing research to Democratic and Republican Congressional offices. Our focus in 2021 was preparing a major policy report showing that Defense Department accession policy concerning individuals born with intersex conditions are inconsistent with other military accession standards. We researched and wrote the report, working closely with coalition partners, obtained more than 20 group endorsements of the report, and presented our findings in Congress and the Defense Department. In addition, we worked closely with officials and administrators in the Veterans Health Administration, who requested extensive research support to inform internal deliberations about the possible reversal of the VHA's prohibition against offering gender affirming surgery in its medical benefits package. Finally, we prepared a policy memo on military service by non-binary transgender individuals, and our recommendations were presented to senior Defense Department officials. In 2021, the Palm Center worked with a range of coalition partners including Cornell Universitys What We Know Project; National Center for Lesbian Rights; GLBTQ Legal Advocates & Defenders; National Center for Transgender Equality; Modern Military Association of America; SPART*A; Transgender American Veterans Association, TransMilitary, Transgender Law Center, Human Rights Campaign Foundation, Lambda Legal Defense and Education Fund; Iraq and Afghanistan Veterans of America; interAct; American Civil Liberties Union Foundation; and Center for American Progress. All of the previous factors demonstrate that Palm Center is a publically supported Organization.
