TREATMENT OF PREVENTABLE ILLNESSES, LIKE CATARACTS, LOW VISION AND LOW HEARING, IS ONE OF THE MOST EFFECTIVE WAYS TO LIFT PEOPLE OUT OF POVERTY, ESPECIALLY FOR VULNERABLE COMMUNITIES LIKE REFUGEES LIVING IN MAKESHIFT ENVIRONMENTS. THEY REGAIN THEIR INDEPENDENCE AND CONFIDENCE TO APPROACH ECONOMIC OPPORTUNITIES AND EDUCATION.GIFTS IN KINDUMR BOASTS A STRONG MEDICAL GIFT IN KIND SUPPLY CHAIN. WE WORK WITH PRIVATE MEDICAL PROVIDERS TO PROCURE MEDICAL SUPPLIES RANGING FROM DISPOSABLES SUCH AS GLOVES, BANDAGES, AND PRESCRIPTION MEDICATIONS TO EQUIPMENT CRITICAL TO THE SUCCESS OF A HEALTHCARE INSTITUTION SUCH AS X-RAY AND ULTRASOUND MACHINES. THIS IS A CRITICAL TOOL FOR CAPACITY BUILDING OF HOSPITALS AS IT FREES UP MONETARY RESOURCES TO HIRE NEW DOCTORS AND REDUCE THE COST BURDEN ON PATIENTS. UMR DELIVERED FIVE HEALTH KITS TO BEIRUT, LEBANON FOLLOWING THE TRAGIC BLAST THAT TOOK PLACE ON AUGUST 4, 2020. SIMILAR MEDICAL EQUIPMENT SHIPMENTS WITH ESSENTIAL MEDICAL SUPPLIES WERE ALSO DELIVERED IN PALESTINE, YEMEN, AND SUDAN, IN COOPERATION WITH THE NATIONAL MINISTRIES OF HEALTH AND IMPLEMENTATION PARTNER PURE HANDS. STANDARD SUPPLIES INCLUDED SYRINGES, ALUMINUM CANES, CRUTCHES, HIP ARTHROSCOPY KITS, OXYGEN MASKS AND SURGICAL PACKS.IN 2020 THE ORGANIZATION PROVIDED IN-KIND PHARMACEUTICAL DONATION AND MEDICAL SUPPLIES AND EQUIPMENT TO THE FOLLOWING COUNTRIES:SUDAN \$ 13,239,164YEMEN 9,710,759LEBANON 6,355,042PALESTINE 3,821,650USA 913,292

UMR INSTITUTE OPERATES DOMESTICALLY AND INTERNATIONALLY TO ENHANCE CAPACITY BUILDING FOR COMMUNITY-BASED ORGANIZATIONS AND INFORMAL AID NETWORKS, ADDITIONALLY IT SERVES AS NONPROFIT INCUBATOR FOR YOUNG LEADERS TO BUILD A FUTURE GENERATION OF VOLUNTEERS AND SOCIAL ENTREPRENEURS. THE UMR INSTITUTE COLLABORATES WITH ITS UNIVERSITY, NGO, PRIVATE, AND GOVERNMENT PARTNERS FOR EXTERNAL RESOURCES AND TRAINING MATERIALS. UMR INSTITUTE IS BUILT UPON FOUR PILLARS: INNOVATIVE PROJECTS LIKE MYCHA (MENA YOUTH CAPACITY BUILDING PROJECT ON YOUTH-LED HUMANITARIAN ACTION), WHICH AIMS TO EMPOWER YOUNG PEOPLE IN HUMANITARIAN SETTINGS, ASSURING THEIR MEANINGFUL PARTICIPATION IN PREPAREDNESS AND RESPONSE. THIS INITIATIVE IS IN CONJUNCTION WITH 53 NOTABLE ORGANIZATIONS INCLUDING ROTA (REACH OUT TO ASIA), NRC, AND UNFPA. UMR HAS LED TRAININGS FOR APPROXIMATELY 150 YOUNG PEOPLE ACROSS: TURKEY, QATAR, TUNISIA, AND JORDAN.

OUR QURBANI AND RAMADAN FOOD PROGRAMS DO NOT ONLY AIM TO ALLEVIATE POVERTY AND MALNOURISHMENT WITH ACCESS TO NUTRITIOUS FOOD, BUT ALSO WORKS TO OVERCOME BARRIERS TO ACCESS AND TO SOCIAL INCLUSION WHICH ARE SPECIFIC TO REFUGEES, THE INTERNALLY DISPLACED, AND MARGINALIZED COMMUNITIES.EMERGENCY RESPONSEON AUGUST 4, 2020, A MASSIVE EXPLOSION AT THE PORT OF BEIRUT, LEBANON, CAUSED AT LEAST 204 DEATHS, 7,500 INJURIES, AND \$15 BILLION USD IN PROPERTY DAMAGE, AND LEFT AN ESTIMATED 300,000 PEOPLE HOMELESS. THE DAMAGE REQUIRED IMMEDIATE YET HIGHLY CUSTOMIZED SOLUTIONS. UMR QUICKLY DEPLOYED A DAMAGE ASSESSMENT IN PARTNERSHIP WITH THE PRIVATE SECTOR, AND TOGETHER APPLIED A SEAMLESS AND EFFICIENT CASE MANAGEMENT PROCESS. IN PARTNERSHIP WITH AKKAROUNA ANDINSAN ASSOCIATIONS, OUR ARCHITECT TEAMS CONDUCTED FIELD VISITS TO CLASSIFY AND PRIORITIZE THE TYPES OF DAMAGE (I.E., A BROKEN WINDOW OR GLASS DOOR, A BENT OR DEFORMED FRAME, OR A FULLY DAMAGEDALUMINUM OR WOODEN DOOR OR WINDOW), THEN PROCEEDED WITH THE APPROPRIATE WINDOW GLASS PANE INSTALLATION. WHERE NECESSARY, SHELTER SOLUTIONS WERE OFFERED TO AFFECTED HOUSEHOLDS. IN OUR RESPONSE TO THE BEIRUT BLAST, WE HAVE APPLIED TWO NEW PROCESSES THAT HAVE RESULTED IN GREAT GAINS. IN PAKISTAN, UMR IMPLEMENTED A WASH AND WATER WELLS PROJECT IN COOPERATION WITH THE RESEARCH AND DEVELOPMENT FOUNDATION (RDF) TO CONSTRUCT 26 WATER PUMPS IN RURAL AREAS OF (I.E., DISTRICT MIRPURKHAS, SANGHAR, HYDERABAD AND SUJAWAL) IN THE SINDH PROVINCE. AND IN BANGLADESH, UMR PARTNERED WITH THE BANGLADESH ENVIRONMENT AND DEVELOPMENT SOCIETY (BEDS) TO CONSTRUCT EIGHT WATER PUMPS IN THE SUNDERBANS COASTAL REGION, WHERE THE DRINKING WATER CRISIS IS EXTREME. CONSTRUCTIONS WERE HANDED OVER TOLocal COMMITTEES IN EACH PROVINCE TO BOLSTER MAINTENANCE AND SUSTAINABILITY.WOMEN EMPOWERMENT & LIVELIHOODS:UMR'S JASMINE PROJECT, ORIGINALLY A SINGLE FLAGSHIP PROJECT, WILL SOON GRADUATE TO BECOME A FULL PROGRAM WITH INTEGRATED SUB-PROJECTS. THE JASMINE PROJECT ADVANCES THE ECONOMIC EMPOWERMENT OF SYRIAN REFUGEE WOMEN THROUGH SKILLS DEVELOPMENT AND ENTREPRENEURSHIP TRAINING. UMR'S GOAL IS TO PROVIDE THE NECESSARY TOOLS FOR WOMEN TO TURN THEIR ABILITIES INTO MARKETABLE SKILLS THAT WILLALLOW THEM TO PROSPER. JASMINE'S TRAININGS ARE NOT LIMITED TO COMMUNITY WOMEN, BUT ALSO TARGET YOUTH IN UNIVERSITIES AND SCHOOLS DURING SUMMER BREAK TO TEACH THEM PROFESSIONAL CRAFTS AND HANDICRAFTS. THE JASMINE PROJECT HAS 13,229 DIRECT BENEFICIARIES SO FAR, WITH MORE THAN 66,000 INDIRECT BENEFICIARIES WHEN TAKING INTO ACCOUNT RELATED FAMILIES AND HOUSEHOLDS.
