Anti-Harassment Training: Right To Be holds cutting-edge anti-harassment training on how to effectively prevent and respond to harassment including bystander intervention, conflict de-escalation, implicit bias, and resilience. Research in 2021 shows 76% of attendees who saw harassment after attending one of Right To Be's trainings reported that they intervened.

Sharing Stories of Harassment: HeartMob (iheartmob.org) is Right To Be's online platform for individuals to share and document their experiences of harassment - and to receive real-time support from bystanders. Since 2005, weve collected over 32,000+ stories of harassment.
