Conferences:Conducted a Annual membership conference in Boise in June 2022 and a hybrid Fall conference in November 2021. Conducted all planning, agenda development, and follow-up activities related to the state-only meeting of NAMD members and senior staff. During the conferences there were several meetings, board discussions related to organizational business. Attendance at the 2022 Annual membership meeting was approximately 180 in person and virtual representing 43 states and territories. Total in person and virtual attendance at the 2021 Fall Conference was approximately 1,181 representing 50 states and territories.
