Conferences: Conducted an Annual membership conference in Minneapolis in May 2023 and a hybrid Fall conference in November 2022. Conducted all planning, agenda development, and follow-up activities related to the state-only meeting of NAMD members and senior staff. During the conferences there were several meetings, board discussions related to organizational business. Attendance at the 2023 Annual membership meeting was approximately 215 in person and virtual representing 54 states and territories. Total in person and virtual attendance at the 2022 Fall Conference was approximately 1,400 representing 53 states and territories.
