The mission of NAMD is to help millions of people served by Medicaid by representing, elevating, and supporting state and territorial Medicaid and CHIP leaders in connecting eligible people to coverage, promoting access to care, providing high value services, and controlling program costs for sustainability. NAMD elevates thought leadership on policy opportunities and operations of the Medicaid and CHIP programs, amplifies the diverse perspectives of Medicaid and CHIP directors, and optimizes federal-state/territory partnerships to help millions live their healthiest lives.

Technical Assistance:Conducted technical assistance calls and webinars, open to all members, for NAMD provided technical assistance through calls and webinars that were open to all members, enabling issue discussions and fostering connections with a broad network of partners and stakeholders. NAMD staff published a weekly newsletter that highlighted critical issues and daily news, and it developed detailed analysis and issue papers for exclusive distribution to NAMD members. Throughout the year, NAMD focused on leadership development and capacity building for Medicaid Directors, senior staff, and agency managers through targeted programs. NAMD engaged over 500 state and territorial Medicaid leaders through an active framework of affinity groups. Led by designated members of the NAMD team, these groups met monthly to discuss specialized topics and share insights. Consistent communication with members was achieved and maintained through weekly leadership calls, monthly Board meetings, and weekly federal update calls. Additionally, NAMD conducted individual check-in calls with each Medicaid Director to review their programs and priorities, ensuring tailored support and guidance.

Conferences: NAMD hosted its annual membership conference in Scottsdale, AZ, in June 2024, which brought together more than 225 attendees representing all 56 states and territories. In October 2023, approximately 1,400 members of the Medicaid community gathered in Washington, DC, for NAMD’s signature Fall Conference, with several participants joining virtually. The NAMD team managed all aspects of planning, agenda development, and follow-up activities for key components of these events, including the state-only meeting for NAMD members and senior staff. Both conferences featured several meetings, including Board discussions focused on organizational strategy and planning.
