IA OFFERS GRANTS AND OTHER FUNDING, DEVELOPS LEARNING TOOLS, AND CURRICULA, AND LEADS CONSULTATIONS AND TRAINING FOR CAMPUS LEADERS. IN 2022, 479 CAMPUSES PARTICIPATED IN SUBSTANTIVE IA PROGRAMS DESIGNED TO ENACT INSTITUTIONAL CHANGE AROUND INTERFAITH ENGAGEMENT.
