IN FALL 2022, IA LAUNCHED THE "INTERFAITH AMERICA WITH EBOO PATEL" PODCAST TO EXPLORE AMERICA'S CHANGING RELIGIOUS LANDSCAPE AND TALK ABOUT THE WAYS RELIGION CAN BE A BRIDGE OF COOPERATION, NOT A BARRIER OF DIVISION.
