In FY25, MediaJustice built community power to challenge how corporations and governments use media and technology. To assess community needs, MJ conducted a seven-city listening tour engaging 47 grassroots organizations to assess the post-election landscape and identify emergent needs. As a result, MJ launched 11 political education workshops in English and Spanish making meaning of the political moment and how to respond. Over 155,000 people viewed the series, and our organizing and communications tools were downloaded over 3,000 times. MJ provided technical assistance, narrative strategy, and campaign support to 20 communities, and pursued interventions to protect consumer privacy, defend communications rights and access, and keep public dollars from funding surveillance tech.
