IN 2023, WE BUILT UPON OUR WORK ADDRESSING GLOBAL HUMANITARIAN AND DEVELOPMENT CHALLENGES THROUGH THE POWER OF DATA AND EVIDENCE, FOCUSING ON THE INCREASING INTERSECTION OF CLIMATE CHANGE, ECONOMIC INSTABILITY, AND CONFLICT. THE WAR IN UKRAINE CONTINUED TO HAVE FAR-REACHING CONSEQUENCES, COMPOUNDING HUMANITARIAN CRISES AND EXACERBATING FOOD AND ENERGY SHORTAGES WORLDWIDE. MEANWHILE, ONGOING CRISES IN REGIONS SUCH AS THE HORN OF AFRICA, THE SAHEL, AND SOUTH ASIA REINFORCED THE URGENT NEED FOR IMPROVED DATA-DRIVEN DECISION-MAKING AND MORE SUSTAINABLE FINANCING SOLUTIONS.OUR WORK IN UGANDA CONTINUED TO SUPPORT DISTRICTS IN STRENGTHENING SUB-NATIONAL DATA VALUE CHAINS, IMPROVING PUBLIC SECTOR TRANSPARENCY AND ACCOUNTABILITY ACROSS ESSENTIAL SERVICES, INCLUDING HEALTHCARE, EDUCATION, AND EMPLOYMENT. WE PUBLISHED EXTENSIVE RESEARCH ON THE ROLE OF REFUGEE-LED ORGANIZATIONS AND THE NEED TO ENSURE SUFFICIENT FUNDING FOR THEIR WORK. THIS WORK WAS HIGHLIGHTED AT THE GLOBAL REFUGEE FORUM AND IN OTHER SETTINGS. OUR RESEARCH AND ADVOCACY EFFORTS EMPHASIZED THE GROWING DISPARITY IN CRISIS FINANCING, PARTICULARLY THE DISPROPORTIONATE LEVELS OF SUPPORT ALLOCATED TO DIFFERENT HUMANITARIAN EMERGENCIES. THE GLOBAL HUMANITARIAN ASSISTANCE REPORT 2023 UNDERScoreD THE WIDENING GAP BETWEEN NEEDS AND AVAILABLE FUNDING WHILE ALSO EXAMINING HOW CLIMATE-RELATED DISASTERS SUCH AS FLOODS, DROUGHTS, AND CYCLONES ARE INCREASINGLY DRIVING DISPLACEMENT AND VULNERABILITY. WE HIGHLIGHTED THE IMPORTANCE OF DATA AND EVIDENCE TO BETTER INFORM CLIMATE FINANCE, INCLUDING AT THE COP28 MEETING IN UAE. WE MAINTAINED A STRONG FOCUS ON DEVELOPMENT FINANCE, LAUNCHING NEW ANALYTICAL TOOLS TO IMPROVE AID TRACKING AND TRANSPARENCY. OUR RESEARCH EXAMINED SHIFTING TRENDS IN OFFICIAL DEVELOPMENT ASSISTANCE (ODA), THE IMPACT OF GLOBAL ECONOMIC DOWNTURNS ON DEVELOPMENT BUDGETS, AND THE POTENTIAL OF INNOVATIVE FINANCING MECHANISMS TO SUPPORT SUSTAINABLE DEVELOPMENT. WE CONTINUED TO ADVOCATE FOR REFORMS IN GLOBAL FINANCIAL ARCHITECTURE, WORKING WITH PARTNERS TO SHAPE DISCUSSIONS AROUND GLOBAL PUBLIC INVESTMENT (GPI) AS A MORE INCLUSIVE AND EFFECTIVE FINANCING MODEL.
