THE ENVIRONMENTAL COMMUNITY AND DEFENSE PROVIDES FREE LEGAL AND TECHNICAL ASSISTANCE AND REPRESENTATION TO THOSE "LIVING DOWNWIND, DOWNSTREAM, AND DOWNHILL AND WHO ARE AFFECTED BY ENVIRONMENTAL POLLUTION. KRC PROVIDES REPRESENTATION TO INDIVIDUALS WHO CANNOT AFFORD OR FIND REPRESENTATION, NON-PROFIT AND COMMUNITY ORGANIZATIONS, AND CIVIC GROUPS ON A RANGE OF ISSUES THAT PROMOTE ENVIRONMENTAL JUSTICE. IN FY 21, KRC CONTINUED TO OFFER PRO BONO LEGAL ASSISTANCE ON EXISTING CASES AND ACCEPTED A NUMBER OF NEW CASES, PROVIDING LITIGATION ASSISTANCE ON AIR, WASTE, AND WATER POLLUTION IN 24 COUNTIES IN THE COMMONWEALTH AS WELL AS WORKING ON THREE UTILITY RATE CASES WITH POSITIVE IMPACTS FOR ALL RATEPAYERS IN THE SERVICE AREAS OF LOUISVILLE GAS AND ELECTRIC, KENTUCKY UTILITIES, AND KENTUCKY POWER COMPANY, AND PROVIDING ADVICE TO LOCAL GOVERNMENTS REGARDING SOLID WASTE PLANNING AND HOST AGREEMENTS.

THE CENTER FOR ENVIRONMENTAL POLICY PROGRAM AREA DEVELOPS AND SUPPORTS PROACTIVE POLICIES, PROPOSED MODEL LAWS AND ORDINANCES TO PROMOTE HEALTHY COMMUNITIES AND A HEALTHY ENVIRONMENT IN KENTUCKY. OFTEN, KENTUCKY'S ENVIRONMENTAL CHALLENGES CAN BE ADDRESSED THROUGH THE DEVELOPMENT OF SMART, RESPONSIBLE POLICIES AND MEASURES THAT CREATE SAFER COMMUNITIES. IN FY2021, KRC PUBLISHED THREE BACKGROUND POLICY PAPERS TITLED "PLANNING, ZONING, AND HAZARDOUS LIQUIDS PIPELINES," "HOST AGREEMENTS 101, AND "ELECTRONIC WASTE: MAKING THE CASE FOR E-WASTE RECYCLING PROGRAMS." ADDITIONALLY, KRC AUTHORED A MODEL SOLAR ZONING ORDINANCE AND ACCOMPANYING POLICY PAPER. CEP ALSO ENGAGED, WITHIN THE LIMITS ESTABLISHED BY THE IRS, LIMITED LOBBYING REGARDING ENVIRONMENTAL AND ENERGY POLICY MATTERS, INCLUDING OPPOSING OVERBROAD LANGUAGE THAT WOULD HAVE CRIMINALIZED PROTECTED SPEECH AND ASSEMBLY RELATING TO KEY INFRASTRUCTURE ASSETS. KRC ALSO PUBLISHED PUBLIC COMMENTS ON A NUMBER OF SUBJECTS INCLUDING SOLID WASTE PLANNING, PERMITTING, NET-METERING, AND REVISIONS TO KENTUCKY'S OIL AND GAS REGULATIONS.
