WE CONTINUE TO PROVIDE FREE LEGAL ASSISTANCE TO INDIVIDUALS AND COMMUNITY GROUPS LIVING "DOWNWIND, DOWNSTREAM, AND DOWNHILL" OF ENVIRONMENTAL PROBLEMS, WHO CANNOT AFFORD OR FIND REPRESENTATION. WE ALSO WORK PROGRAMMATICALLY THROUGH LITIGATION AND ADVOCACY TO IMPROVE THE QUALITY OF LIFE FOR ALL KENTUCKIANS AND TO ASSURE THAT THOSE WHO POLLUTE OUR LAND, AIR, OR WATER ARE HELD ACCOUNTABLE.
