TENANT EDUCATION PROGRAM - THE TENANT EDUCATION DEPARTMENT SERVED OVER 2,000 HOUSEHOLDS IN OREGON THROUGH OUR RENTERS' RIGHTS HOTLINE. STAYING TRUE TO OUR MISSION AND VALUES OF SERVING THE MOST VULNERABLE MEMBERS OF OUR COMMUNITIES, ABOUT 50% OF THE RENTERS WE SERVED WERE EXTREMELY LOW INCOME (0-30% MFI) AND ABOUT 40% OF THEM IDENTIFIED AS HAVING A DISABILITY. WE WOULD NOT HAVE BEEN ABLE TO HELP AS MANY RENTERS AS WE DID WITHOUT THE MANY VOLUNTEERS WHO HELPED US RETURN CALLS ON OUR HOTLINE, HELPED PRESENT HELPFUL INFORMATION AT COMMUNITY EVENTS SUCH AS FAIRS AND WORKSHOPS.
