Network Defense: Alianza Americas works in a network to promote humane, fair and equitable policies. This work is carried out at the local, federal, regional level in the Americas and worldwide. Education and Formation: Educate migrants and the general public on issues related to public policies, human rights, democratic strengthening, and their link to the migratory phenomenon. Furthermore, we are committed to the political training of migrants. Some of our bets are: Leadership Institute - Focused on developing the critical and organizational thinking capacities of migrants and members of our network. Virtual Seminars - Connect specialist voices on various topics related to our work to provide analysis and interaction through virtual tools. Forums and Discussions - Organize and co-organize face-to-face spaces that promote the analysis and understanding of different problems of national, transnational and international events. Delegations and Tours: Alianza Americas organizes educational tours in the United States, Mexico and Central America for elected officials, human rights defenders, religious leaders, journalists and others who can take steps to improve the lives of immigrants, deportees and people at risk of forced migration. Save TPS: In response to the cancellation of Temporary Protected Status (TPS) programs, we activated a nationwide community organizing strategy led by our members, including the House for House campaign in key cities in the USA This organization and mobilization led by Alianza Americas and member organizations have enabled our network and partner organizations in various states to engage hundreds of TPS holders so they could tell their own stories to policymakers in Congress and advocate for permanent solutions, and for immediate measures to protect TPS holders. Recent results our organizational strategy: Two congressional briefings on TPS, DACA and DED, held in Washington, DC More than 200 visits to Congress made between June 2017 and September 2019. Participation of 800 TPS holders in events of the Casa en Casa campaign by TPS. 10,000 people attend TPS events, such as community forums in Houston, San Francisco, Los Angeles, Boston, New York, New Jersey, Chicago, Miami, North Carolina and Minnesota. More than 10,000 queries to our virtual TPS toolbox More than 10,000 visits to the two TPS explanatory videos on the demands of Ramos v Nielsen and Bhattarai v Nielsen, uploaded on our Facebook page and on our YouTube channel. 20,000 copies of TPS explanatory brochures distributed in 10 states. Wide network of volunteer spokespersons. House by House campaign implemented in six states. 14 member organizations held discussions with policymakers about contingency plans for TPS holders. Member organizations attended congressional offices in 11 states to raise awareness of TPS Coalition and Joint Campaigns: Alianza Americas collaborates with the Global Coalition on Migration (GCM) and other like-minded organizations to further its goals and objectives. GCM is made up of regional and international networks of migrant associations, organizations and regions of the world. GCM represents a vital space where members can collectively map out the best methods, strategies and tools to act together.
