THESE SOCIAL MEDIA PLATFORMS, SUCH AS INSTAGRAM AND TIKTOK, ARE WHERE YOUNGER CONSUMERS GET MUCH OF THEIR INFORMATION AND NEWS. WE ARE WORKING TO EDUCATE THEM WHERE THEY ARE SPENDING MOST OF THEIR TIME ONLINE.CONTINUED ON SCHEDULE O. OV ALSO HOSTED OUR SECOND ANNUAL, "ORGANIC OSCARS", TO HIGHLIGHT AND CELEBRATE ALL THE AMAZING BRANDS, RETAILERS, SCIENTISTS, LEADERS, AND PEOPLE WITHIN THE ORGANIC INDUSTRY DOING IMPORTANT WORK TO GROW THE INDUSTRY.
