LCFS IDENTIFIES, TRAINS, AND LICENSES FOSTER PARENTS AND PROVIDES ONGOING TRAINING AND HOME VISITS TO ENSURE THE WELL-BEING OF EACH CHILD IN CARE. FAMILY COUNSELING - LCFS OPERATES A WIDE RANGE OF PROGRAMS THROUGHOUT ILLINOIS THAT SUPPORT AND SERVE FAMILIES AND CHILDREN SO THE FAMILY CAN REMAIN TOGETHER. LCFS HAS COUNSELORS THROUGHOUT ILLINOIS WHO CAN HELP WITH SPECIALIZED CARE TO INDIVIDUALS AND FAMILIES FACING DIFFICULT SITUATIONS.
