Medical services: Operates 11 health centers in the Chicago metropolitan area, six in Central Illinois and one in Southern Illinois that provide comprehensive reproductive and sexual health care services to patients regardless of income and a robust telehealth program on two platforms. Services include annual wellness exams, including cervical cancer screenings, and evaluation and management of abnormal cervical cancer screenings; gender-affirming hormone therapy; comprehensive birth control services; reproductive and sexual health services; pregnancy testing and options counseling; testing and treatment for sexually transmitted infections (STI's), including rapid HIV testing; emergency contraception; HPV and Hepatitis A/B vaccines; breast cancer screening; and surgical and medication abortion services.
