Services include annual wellness exams, including cervical cancer screenings, and evaluation and management of abnormal cervical cancer screenings; gender-affirming hormone therapy; comprehensive birth control services; reproductive and sexual health services; pregnancy testing and options counseling; testing and treatment for sexually transmitted infections (STI's), including rapid HIV testing; emergency contraception; HPV and Hepatitis A/B vaccines; breast cancer screening; and surgical and medication abortion services.
