Minnesota Economy & Estate Tax Project:The Minnesota Economy Project was launched in 2016. Its goal is to educate Minnesotans to the fact that the state's economic performance in recent years has not been good, in order to build public and legislative support for lower taxes and less onerous regulation. Since 2016, the Center has published an annual analysis of Minnesota's economic performance in the 21st Century. We have publicized the findings of each paper with press conferences, radio and television appearances, op-eds in dozens of newspapers, radio ads on dozens of radio stations, three internet videos that have now exceeded 2 million views within the State of Minnesota, town meetings and other public appearances, and posts on the Center's web site and Facebook page. In 2018 we published a study of Minnesota's estate tax, which showed that Minnesota could abolish its estate tax without losing any significant amount of net tax revenue, and might actually gain tax revenue. In 2019 we published an important study on Minnesota's workforce. Though Minnesota has a high labor participation rate and, therefore, relatively high GDP per capita, concerns on the horizon include below average labor productivity, higher minimum wages, and a rise in occupational licensing hurdles.In 2020 we published a paper in which we used comparisons between border counties to assess the impact of state policy on a variety of economic outcomes. We found that, as the existing empirical evidence suggests, higher taxes are associated with worse economic outcomes. Also in 2020 we published a study recommending spending cuts and not tax hikes as a solution to closing Minnesota's budget deficit. Our findings show that Minnesota is one of the most highly taxed states in the nation and is also spending more now than at any other point in history -- both per capita and inflation-adjusted terms. Furthermore, tax hikes hurt economic growth and they do not increase revenue. Our policy goals include abolition of the estate tax; spending restraint to allow tax cuts; personal and corporate income tax rate cuts; regulatory reform; and promoting pension transparency and reform. Other Center projects will also contribute to a stronger Minnesota economy.

Thinking Minnesota Magazine: Thinking Minnesota is an important communications vehicle for the Center, with a base circulation of more than 100,000. The Center's goal is to continue to build circulation while using the magazine to spread conservative ideas and promote the Center.Sharp content and compelling graphics have driven the popularity of Thinking Minnesota. In order to reduce the net cost of the magazine we sell ads in the magazine, and also solicit contributions to help keep Thinking Minnesota free.In 2018 we added a top-notch, professional poll to our magazine conducted by Meeting Street Research. For each issue we survey issues that are covered in our magazine so legislators and opinion leaders will know what Minnesotans think on key issues.Thinking Minnesota broadly advances the policy goals on which the Center is working. It also promotes the Center and exposes new potential donors to our work.

Open MN/COVID Common Sense:To highlight the economic devastation many residents were facing from government shutdowns, American Experiment launched the "Back 2 Work Minnesota" campaign in the summer of 2020. The goal was to put pressure on the Minnesota Governor and state legislators to relax the coronavirus-related shutdowns to the greatest extent possible. Back 2 Work Minnesota included a website, op-eds, and blog posts encouraging Minnesota's leaders to end the coronavirus shutdown. American Experiment also shared a video that highlighted business owners struggling through the pandemic.Later in 2020 after Gov. Tim Walz issued Executive Order 20-99, American Experiment immediately launched a second grass roots effort (www.COVIDCommonsenseMN.com) to convince him to relax restrictions on bars, restaurants, health clubs and youth sports. The campaign helped 11,000 Minnesotans send 33,000 letters to Gov. Walz and their State Representatives and Senators.

Forums:American Experiment continues its tradition of addressing important and timely topics through public forums. In 2020 we held one traditional lunch forum in March with historian Amity Shlaes. After the COVID lockdown, we held 13 free online webinars in place of the traditional in-person forums. These forums featured our own policy fellows and a variety of guest speakers such as Governor Kristi Noem, Congressman Tom Emmer, scholar Heather MacDonald, and even comedian Adam Carolla. Our speakers engaged with audience members in lively Q&A segments following their presentations. We reached tens of thousands of viewers during these live events, and hundreds of thousands more through the recordings of these events that live on. After the lockdown restrictions eased, we hosted an evening forum on the topic of election fraud that was attended by 150 Minnesotans. The panel featured both national and local experts on the issue, and was one of the only events happening in-person at the time. While conducting events online was not our plan for 2020, we quickly adapted and even reached an audience we never had before. We look forward to using a hybrid online and in-person approach to events in the future.

Education Legislation/Social Studios:In 2020, the Minnesota Department of Education and its hand-picked Social Studies Standards Committee released a first draft of proposed revisions to the state's K-12 social studies standards. American Experiment was the first to do an in-depth comparison between the first draft and the current standards in place, and launched the Raise Our Standards MN campaign to inform Minnesotans of the concerning omissions, revisions, and additions to the proposed social studies content that our K-12 students will or will not learn. Because of American Experiment's efforts, the revision process received national coverage, thousands of Minnesotans submitted feedback to the Minnesota Department of Education voicing concern over the first draft, and the revision timeline has been slowed down.

The Great Jobs Without a Four-Year Degree:The Great Jobs Without a Four-Year Degree Project commenced in 2017. Its purpose is to encourage more young people and their parents to consider alternatives to conventional four-year degree programs, in the form of apprenticeships, technical schools, certificate programs, the military, and others. The project is ambitious: it aims both to help young people by encouraging them to pursue lucrative and rewarding career paths, and also to benefit employers and Minnesota's economy by addressing the "skills gap" that restricts productivity.The Great Jobs project includes multiple elements. The Center is working with educational institutions, employers, unions, academics and others to coordinate the efforts of groups working to promote similar goals, and to publicize the work done by those groups. The Center's approximately biweekly email communications are directed at this audience. At the same time, the Center's public information campaign is aimed directly at young people and their parents. The Center's public information campaign includes a web page, GreatJobsMN.com, radio ads, op-eds, posts on the Center's web and Facebook sites, public meetings, and research papers that are promoted with press conferences, follow-up op-eds, and so on. But the main focus of the Center's information campaign is social media, where we have reached young Minnesotans more than 1.6 million times.A two-day Zoom event in 2020 featured several different technical schools and organizations and their efforts to build a bridge to younger generations in trades and manufacturing. Not only did the webinar share knowledge and resources with parents and students, it also helped connect educational institutions, employers, and others who are all working to promote rewarding career paths that don't require a baccalaureate degree and address the "skills gap" that restricts productivity in the state.Our policy goals are greater public awareness of the high-quality jobs available through technical education, a better match of skills training with employers' skills needs, and a higher appropriations priority for technical education.

Energy Initiative:In 2020, our Energy Initiative continued to work to protect Minnesota families and businesses from policies that would increase the cost of energy. We educate Minnesotans about how adding weather-dependent resources like wind and solar energy to the grid drives up the cost of keeping the lights on. Our policy goals include preserving existing power plants to the benefit of ratepayers and the reduction or elimination of wind and solar energy mandates.We also updated our mining report to reflect the massive economic potential that non-ferrous mining would have on our state.

	Educated Teachers:The Educated Teachers Project seeks to educate Minnesota's teachers about the union membership options available to them following the U.S. Supreme Court's Janus decision in June 2018. The project also informs educators on how union dues are spent by Education Minnesota, the state's teachers union. The Janus decision restored public employees' right not to be required to financially support a public-sector union as a condition of employment. American Experiment has informed teachers of their rights and how the union prioritizes left-wing causes over member representation via direct mail, email, social media, and a website.The project's pressure on Education Minnesota contributed to an expansion of the annual "window" when educators can resign membership from a narrow seven days to 30 days. The project has assisted hundreds of Minnesota teachers with exercising their right to opt-out. Our policy goals include fully eliminating the window and requiring that teachers opt in to union membership, helping teachers exercise their freedom of choice regarding union membership, and pushing for legislative action on annual union recertification measures.

	Greater Minnesota Initiative:The Greater Minnesota Initiative seeks to extend the Center's influence in Greater Minnesota, to encourage and facilitate the trend toward conservatism in Greater Minnesota, and to enhance the Center's fundraising in Greater Minnesota.While 2020 proved to be a challenging year amidst the COVID-19 pandemic, the Greater Minnesota Outreach Project saw a number of successes. American Experiment partnered with the Minnesota Automobile Dealers Association for a 16-city tour of the state pushing back against the Minnesota Pollution Control Agency's car emission standards. Our efforts reached thousands of Minnesotans and garnered over 20,000 petition signatures. Additionally, American Experiment put on 10 different events in Greater Minnesota on a number of different policy issues. Also, American Experiment's Grassroots network expanded exponentially.Our policy goals include accelerating the process whereby rural Minnesota is becoming more self-consciously conservative across a broad range of issues and giving rural and small-town Minnesotans a voice in state policy decisions that affect their region.

	Employee Freedom:The Employee Freedom Project, launched in 2019, seeks to inform Minnesota public employees, other than teachers, about their rights regarding union membership following the U.S. Supreme Court's Janus decision. In addition to informing government employees about their union membership options, the project assists interested employees in exercising their right to resign from a public-sector union, if they so choose. Through Employee Freedom's One Click Opt Out campaign, interested public employees are assisted with sending a weekly resignation letter to their union in an attempt to overcome resignation "window" barriers. American Experiment's efforts have identified a handful of plaintiffs to cooperate in legal action to enforce the Janus decision that are currently underway.Our policy goals include promoting litigation efforts to remove unconstitutional opt-out "windows and helping public employees exercise their freedom of choice regarding union membership.

	Institutional Promotion:In 2020 the Center made a concerted effort to boost our brand reputation and awareness of our programs by utilizing TV, radio, billboards, and online advertising to reach millions of Minnesotans across the entire state.

	Non-profit Community Support.The Center takes a leadership role in the conservative, free market movement by making grants to other worthy non-profits doing important work.

	Spending/Golden Turkey:The Center launched the Golden Turkey Awards in November 2020 to highlight examples of wasteful government spending in Minnesota. The Golden Turkey Award is a light-hearted contest to bring attention to the budget and allow Minnesotans to weigh in on the silliest spending of the year. The first Golden Turkey was awarded to Gov. Tim Walz for spending \$6.9 million on a morgue that thankfully was never needed to house COVID-19 bodies. The second Golden Turkey Award was awarded in March 2021 to the \$7.2 million Goose Creek Rest area with its curved glass, Brazilian wood, a modern play area and bathrooms fit for a fancy hotel.For each award, American Experiment nominated four projects and conducted a weeks-long vote on a landing page housed on our website. We promoted the voting with a comprehensive marketing campaign that included email, social, digital and outdoor advertising.

	Youth/Project Fairness:American Experiment launched Project Fairness to figure out how young people define fairness in modern society. We produced a series of videos using the Socratic method to examine general questions of fairness based on participants' ideas and lived experiences. The campaign included a website (www.project-fairness.com) and a Facebook advertising campaign directed at young people in Minnesota.

	Support MN Police:American Experiment launched a public awareness campaign in the summer of 2020 to inform Minnesotans of the dramatic increase in violent crime in the Twin Cities and give law enforcement supporters a voice in the public debate over the role of police in our communities.The campaign included 38 billboards across the greater metro area feature striking quotes from local media reports on violent attacks in the Twin Cities metro. Minnesotans were encouraged to visit the website SupportMNPOLice.com, where they could sign a petition to support law enforcement, see crime data, learn about recent polling on Minnesotans' views on police, and browse related news reports and commentary.
