Center of the American Experiment is a nonpartisan public policy and educational institution that brings conservative and free market ideas to bear on the hardest problems facing Minnesota and the nation. Through research, op-eds, public forums, legislative testimony, public messaging in a variety of media, and a stream of publications, we are working to build a Culture of Prosperity in Minnesota and the nation.

Minnesota Economy:The Minnesota Economy Project was launched in 2016. Its goal is to educate Minnesotans to the fact that the state's economic performance in recent years has not been good, in order to build public and legislative support for lower taxes and less onerous regulation. Since 2016, the Center has published an annual analysis of Minnesota's economic performance in the 21st Century. We have publicized the findings of each paper with press conferences, radio and television appearances, op-eds in dozens of newspapers, radio ads on dozens of radio stations, three internet videos that have now exceeded 2 million views within the State of Minnesota, town meetings and other public appearances, and posts on the Center's web site and Facebook page. In 2018 we published a study of Minnesota's estate tax, which showed that Minnesota could abolish its estate tax without losing any significant amount of net tax revenue, and might actually gain tax revenue. In 2019 we published an important study on Minnesota's workforce. Though Minnesota has a high labor participation rate and, therefore, relatively high GDP per capita, concerns on the horizon include below average labor productivity, higher minimum wages, and a rise in occupational licensing hurdles.In 2020 we published a paper in which we used comparisons between border counties to assess the impact of state policy on a variety of economic outcomes. We found that, as the existing empirical evidence suggests, higher taxes are associated with worse economic outcomes. Also in 2020 we published a study recommending spending cuts and not tax hikes as a solution to closing Minnesota's budget deficit. Our findings show that Minnesota is one of the most highly taxed states in the nation and is also spending more now than at any other point in history -- both per capita and inflation-adjusted terms. Furthermore, tax hikes hurt economic growth and they do not increase revenue. In 2021, we published a study on how taxes affect migration. The study showed that Minnesota loses highly productive residents to low-tax states. For example, while our state has seen net inflows of domestic migrants in every income category below \$25,000 every year between 2011 and 2018, it has seen net outflows at every income level above \$50,000. Additionally, Minnesota fails to attract residents from other states due to high taxes. We also published two other reports, one showing that tobacco taxes have little to no effect on tobacco use but they encourage smuggling and hurt the poor, who generally use tobacco at higher rates compared to high-income individuals. The other report presented evidence showing that rent control has only managed to bring disastrous consequences in places where it has been used. Our policy goals include abolition of the estate tax; spending restraint to allow tax cuts; personal and corporate income tax rate cuts; regulatory reform; and promoting pension transparency and reform. Other Center projects will also contribute to a stronger Minnesota economy.

Thinking Minnesota Magazine: Thinking Minnesota is an important communications vehicle for the Center, with a base circulation of more than 100,000. The Center's goal is to continue to build circulation while using the magazine to spread conservative ideas and promote the Center.Sharp content and compelling graphics have driven the popularity of Thinking Minnesota. In order to reduce the net cost of the magazine we sell ads in the magazine, and also solicit contributions to help keep Thinking Minnesota free.In 2018 we added a top-notch, professional poll to our magazine conducted by Meeting Street Research. For each issue we survey issues that are covered in our magazine so legislators and opinion leaders will know what Minnesotans think on key issues.Thinking Minnesota broadly advances the policy goals on which the Center is working. Forums:American Experiment continues its tradition of addressing important and timely topics through public forums. In 2021 we held 46 events- 40 in-person and 6 virtually. One of these virtual events was a forum with Congressman Tom Emmer. The others were on education, energy, regulations, taxation, and more. In the summer we hosted a two event forum with Isaac Orr and national energy expert Robert Bryce. This included a lunch in Albert Lea and an evening event in Golden Valley. These were both very successful events, attended by 300+ people altogether. A large portion of summer event programming was spent on the Raise Our Standards Tour. We went across the entire state, putting on 22 programs to educate Minnesotans on Critical Race Theory, and what is being taught in our schools. Four of these stops were in the suburban Twin Cities, hitting the north, south, east, and west. In September we added Shoreview and Chaska to the tour, and 3 stops in Greater Minnesota.Overall more than 7,000 Minnesotans attended our events in 2021. 26 of the events took place in Greater Minnesota. We specifically reached out to young people again through our YLC program for the first time in a few years. We partnered with other groups, set foot outside the state again, and continued to choose speakers and topics that are relevant to our audience.

Education/Standards:In 2020, the Minnesota Department of Education and its hand-picked Social Studies Standards Committee released a first draft of proposed revisions to the state's K-12 social studies standards. American Experiment was the first to do an in-depth comparison between the first draft and the current standards in place.In 2021 we continued to provide analysis of the subsequent drafts through the Raise Our Standards MN campaign. This campaign has informed Minnesotans of the concerning omissions, revisions, and additions to the proposed social studies content that our K-12 students will or will not learn. Because of American Experiment's efforts, the revision process received national coverage, tens of thousands of Minnesotans submitted feedback to the Minnesota Department of Education voicing concern over the first draft, and the revision timeline has been slowed down. American Experiment will continue to weigh in on the proposed standards as they make their way through the rulemaking process.

Energy:In 2021, our Energy Initiative continued to work to protect Minnesota families and businesses from policies that would increase the cost of energy. We educate Minnesotans about how adding weather-dependent resources like wind and solar energy to the grid drives up the cost of keeping the lights on. Our policy goals include preserving existing power plants to the benefit of ratepayers and the reduction or elimination of wind and solar energy mandates. We also modeled the cost of various energy proposals in other states, including Arizona, Michigan, North Carolina, and West Virginia.

Educated Teachers/Employee Freedom:The Educated Teachers Project seeks to educate Minnesota's teachers about the union membership options available to them following the U.S. Supreme Court's Janus decision in June 2018. The project also informs educators on how union dues are spent by Education Minnesota, the state's teachers union. The Janus decision restored public employees' right not to be required to financially support a public-sector union as a condition of employment. American Experiment has informed teachers of their rights and how the union prioritizes left-wing causes over member representation via direct mail, email, social media, and a website.The project's pressure on Education Minnesota contributed to an expansion of the annual "window" when educators can resign membership from a narrow seven days to 30 days. The project has assisted thousands of Minnesota teachers to exercise their right to opt out of union membership. Our policy goals include fully eliminating the window and requiring that teachers affirmatively opt in to union membership, helping teachers exercise their freedom of choice regarding union membership, and pushing for legislative action on annual union recertification measures.The Employee Freedom Project, launched in 2019, seeks to inform Minnesota public employees, other than teachers, about their rights regarding union membership following the U.S. Supreme Court's Janus decision. In addition to informing government employees about their union membership options, the project assists interested employees in exercising their right to resign from a public-sector union, if they so choose, and helps public-sector employees exercise their right to not financially support the union's political activities. Through Employee Freedom's One Click Opt Out campaign, interested public employees are assisted with sending a weekly resignation letter to their union in an attempt to overcome resignation "window" barriers. American Experiment's efforts have identified plaintiffs to cooperate in legal action to enforce the Janus decision, and those efforts have largely been successful.Our policy goals include promoting litigation efforts to remove unconstitutional opt-out "windows and helping public employees exercise their freedom of choice regarding union membership.

	Greater Minnesota Initiative:The Greater Minnesota Outreach initiative seeks to extend the Center's influence outside the metro area. We help to encourage and facilitate the trend toward conservatism, in addition to expand the Center's fundraising. In 2021, we saw enormous gains. We increased our Greater Minnesota chapters to three (Rochester, Owatonna and Duluth). The program featured 23 events in cities in Greater Minnesota. We expanded our fundraising apparatus, while also increasing our network of contacts. And we continued our outreach by once again having a booth at the annual FarmFest trade show. Our policy goals include accelerating the process whereby rural Minnesota is becoming more self-consciously conservative across a broad range of issues, giving Minnesotans outside the metro a voice.

	Institutional Promotion:In 2021 the Center continued a concerted effort to boost our brand reputation and awareness of our programs by utilizing radio, billboards, and online advertising, as well as a marketing partnership with University of Minnesota athletics, to reach millions of Minnesotans across the entire state.

	Non-profit Community Support:The Center takes a leadership role in the conservative, free market movement by making grants to other worthy non-profits doing important work.

	Spending/Golden Turkey:The Center awarded our third Golden Turkey Award in November 2021 to highlight examples of wasteful government spending in Minnesota. The Golden Turkey Award is a light-hearted contest to bring attention to the budget and allow Minnesotans to weigh in on the silliest spending of the year. The winner was the Newport Transit Station, which opened in 2014 and cost taxpayers \$6.45 million. At that time, the Met Council boasted ridership of eight passengers a day on the bus line serving the Newport Transit Station. In the post-COVID world, there are no buses serving this sprawling transit stop, which left the Newport Transit Station with an empty 150-car parking lot and a Golden Turkey Award.For each award, American Experiment nominated four projects and conducted a weeks-long vote on a landing page housed on our website. We promoted the voting with a comprehensive marketing campaign that included email, social, digital and outdoor advertising.

	Youth/Project Fairness:Amercan Experiment launched Project Fairness to explore how young people define fairness in modern society. We produced a series of videos using the Socratic method to examine general questions of fairness based on participants' ideas and lived experiences. The campaign included a website (www.project-fairness.com) and a Facebook advertising campaign directed at young people in Minnesota.

	Support MN Police:Amercan Experiment launched a public awareness campaign in June 2021 to show support for law enforcement in Minnesota during the ongoing public debate over the role of police in our communities. The campaign included Facebook ads, digital ads and a radio campaign in the Twin Cities metro area during June and July. The campaign also included 35 poster sized billboards across the greater metro area and one large billboard at a high traffic intersection. The billboards simply read Support Our Police, Sign the Petition. Minnesotans were encouraged to visit the website SupportMNPolice.com, where they could sign a petition to support law enforcement, see crime data, learn about recent polling on Minnesotans' views on police, and browse related news reports and commentary. Almost 10,000 Minnesotans signed the petition to support our police.

	North Dakota:In order to expand the Center's work to North Dakota, we officially launched fundraising efforts in 2021 for that purpose. A major event was held in Fargo in July, with approximately 250 people in attendance. In addition, meetings were held with several individual donors and potential new staff, with an eye to starting outreach activities across the State in 2022. Funds raised during 2021 are to be used for planning and helping to pay for these 2022 activities.
