ADULT ESL AND LITERACY THE MISSION OF THE ESL/LITERACY PROGRAM IS TO FACILITATE SERVICES IN WHICH QUALITY AND CULTURALLY COMPETENT EDUCATIONAL INSTRUCTION IS ACCESSIBLE TO ALL PEOPLE IN THEIR ADJUSTMENT, INTEGRATION, SELF-SUFFICIENCY, AND MOBILIZATION THROUGH THE ACQUISITION OF THE ENGLISH LANGUAGE. IN ADDITION TO READING, SPEAKING IN ENGLISH IS ALSO MANY OF OUR LEARNERS' MAIN GOAL WHETHER IT IS TO TALK WITH THEIR CHILD'S TEACHER, BECOME A CITIZEN, ATTAIN A JOB OR A HIGHER POSITION IN THEIR JOB, OR TO BECOME AN ACTIVE, INTEGRAL COMMUNITY MEMBER. WE ASSIST OUR LEARNERS' GOALS BY ASSESSING THEM ONCE A MONTH THROUGH STANDARDIZED AND INDIVIDUAL WRITTEN/ORAL ASSESSMENTS, MAINTAINING POSITIVE COMMUNICATION, AND OFFERING LEARNERS HIGHER EDUCATION OPTIONS.
