CSG launched the Comparative Performance Measurement Project, which seeks to collect, analyze and publish comparative performance data so states can better set reachable targets for their services and identify successful state practices.

Activities included briefing House and Senate Appropriations staff and working with the Hill to submit to Congress letters in support of FY2020 funding. The FY20 Omnibus appropriations bill released by the House included \$33 million, up from \$31 million in FY19. State Lobbying During FY20, Legislation in each state was informed by analyses and technical assistance provided at the request of the governor, legislative leaders, and other state officials. In FY20, CSG Justice Center staff registered in four states as lobbyists.
