Federal grants are from the Department of Justice, the Department of Labor, the Department of Defense, the Department of Energy, and other such agencies.

Offices located in each region focus on issues of interest to policymakers and provide state leaders with the resources and tools they need to effectively address today's public policy challenges. Projects include the regional offices as well as specific regional projects such as the Eastern Trade Council, Northeast States Association for Agricultural Stewardship, Midwest Passenger Rail Commission, BOWHAY Institute of Legislative Leaders Development.

4c (Code:) (Expenses \$ 863,175 including grants of \$) (Revenue \$ 562,180)

National and regional conferences which provide a forum for the exchange of information and trends relating to state government issues and state government officials. Provides networking opportunities for state officials from all branches of state government. Topics relating to educational issues, energy issues, health issues, growth and prosperity, environment, transportation, border issues and current economic climate are discussed. Presentations made by expert speakers and panel members.

Public Policy - The Council of State Governments tracks public policy issues in various areas across the country, including in education, health, energy and environment, and transportation at its headquarters office. In addition, several policy programs offer an expanded look into specific categories, such as public safety and justice issues at the national Justice Center, public health issues at Healthy States, combined state efforts in areas of common interest through the National Center for Interstate Compacts, and model legislation through the Suggested State Legislation program. CSG launched the Comparative Performance Measurement Project, which seeks to collect, analyze and publish comparative performance data so states can better set reachable targets for their services and identify successful state practices.

Activities included briefing House and Senate Appropriations staff and working with the Hill to submit to Congress a letter in support of FY2021 funding. The FY21 Omnibus appropriations bill approved by Congress included \$100 million for the program, up from \$90 million in FY20. The CSG Justice Center coordinated efforts to secure funding for the Justice Reinvestment Initiative (JRI) for fiscal year 2020. CSG Justice Center played a pivotal role in garnering continued congressional approval for critical criminal justice programs, including the Justice Reinvestment Initiative. Again, this year, activities included briefing House and Senate Appropriations staff and working with the Hill to submit to Congress letters in support of FY2021 funding. The FY21 Omnibus appropriations bill approved by Congress included \$33 million for the program, up from \$28 million in FY20. The Justice Center coordinated efforts to secure funding for the Mentally Ill Offender Treatment and Crime Reduction Act (MIOTCRA) for fiscal year 2021. Activities included briefing House and Senate Appropriations staff and working with the Hill to submit to Congress letters in support of FY2021 funding. The FY21 Omnibus appropriations bill released by the House included \$35 million, up from \$33 million in FY19. The Justice Center endorsed and worked to pass the VOCA Fix to Sustain the Crime Victims Fund Act of 2021, bipartisan legislation that supports vital victim service programs by preventing future cuts to already diminished federal victim service grants. The VOCA Fix to Sustain the Crime Victims Fund Act will redirect monetary penalties from federal deferred prosecution and non-prosecution agreements into the Crime Victims Fund to increase funding for state victim compensation and assistance programs. The House passed the bill in March 2021 and the Senate in July 2021. President Biden signed the bill on July 22, 2021. Activities included meeting with House and Senate Judiciary staff and working with stakeholders to submit to House and Senate congressional leaders a letter in support of the legislation. During FY21, Legislation in each state was informed by analyses and technical assistance provided at the request of the governor, legislative leaders, and other state officials. In FY21, CSG Justice Center staff was required to register in just one state as lobbyists due to provisions in the state lobbying laws requiring those influencing administrative action be registered as lobbyists. All staff registered during FY21 completed work in Vermont in early June, 2021 and registrations were terminated on June 11, 2021.
