This program aims to address 3 primary college readiness issues faced by Black and Latino youth: (1)access to rigorous college preparatory courses (2) access to experienced teachers who have high levels of cultural competencies when working with boys/men of color (3) access to consistent guidance counseling to continually track students academic performance and college application process. We work with Kings starting at 10th grade through to their senior year on academic advising, tutoring, literacy and reading comprehension, financial literacy, mentorship and career and professional development.
