SHELTER - PROVIDES SAFE, CONFIDENTIAL, HOUSING AND SUPPORTIVE SERVICES TO ADULTS AND THEIR CHILDREN WHO ARE HOMELESS AS A RESULT OF DOMESTIC VIOLENCE, SEXUAL ASSAULT OR HUMAN TRAFFICKING. THE SHELTER OPERATES A CONFIDENTIAL 24 HOUR HOTLINE. THIS PROGRAM ALSO OFFERS DOMESTIC VIOLENCE OR SEXUAL ASSAULT OR ABUSE LEGAL ADVOCACY AND SUPPORT TO INDIVIDUALS SEEKING LEGAL REMEDY IN THE CIVIL AND CRIMINAL JUSTICE SYSTEMS. DURING 2021, THE SHELTER PROVIDED 6,385 NIGHTS OF CARE TO 150 ADULTS AND CHILDREN AND TOOK 6,800 HOTLINE CALLS. THE SHELTER ALSO RECEIVED 617 CLIENT REFERRALS FROM LAW ENFORCEMENT, INCLUDING 236 FACING A HIGH RISK OF HOMICIDE AS DETERMINED THE LETHALITY ASSESSMENT PROGRAM.
