SHELTER OPEN 24 HOURS A DAY, 7 DAYS A WEEK PROVIDES ADULTS AND THEIR CHILDREN WHO ARE HOMELESS AS A RESULT OF DOMESTIC VIOLENCE, SEXUAL ASSAULT OR HUMAN TRAFFICKING, A SAFE PLACE TO STAY. WHILE IN SHELTER, INDIVIDUALS ARE PROVIDED FOOD, CLOTHING, VOUCHERS, TRANSPORTATION, TRANSLATION AND INTERPRETATION IN ANY LANGUAGE, AND OTHER NECESSITIES. THIS PROGRAM PROVIDES TRAINED ADVOCATES TO SUPPORT INDIVIDUALS TO FIND SAFE AND AFFORDABLE HOUSING, CREATE A SAFETY PLAN, AND DEVELOP PERSONAL GOALS AS THEY BEGIN THEIR NEW, INDEPENDENT LIFE FREE FROM VIOLENCE. THIS PROGRAM ALSO OFFERS JOB READINESS TRAINING AND OTHER LIFE SKILLS DEVELOPMENT AND LEGAL ADVOCACY. DURING 2023, THE SHELTER PROVIDED 9013 NIGHTS OF CARE TO 212 ADULTS AND THEIR CHILDREN. THE SHELTER OPERATES A CONFIDENTIAL 24-HOUR HOTLINE RESPONDING TO 6006 CALLS IN 2023. IN 2023, WE RECEIVED 675 REFERRALS FROM LAW ENFORCEMENT, OF WHICH 293 WERE DEEMED TO BE AT HIGH RISK OF HOMICIDE AS DETERMINED BY THE LETHALITY ASSESSMENT PROTOCOL. ADVOCATES FURTHER PROVIDED SUPPORT TO 450 ADULTS AND CHILDREN IN NON-SHELTER RELATED PROGRAMMING.
