Form 990, Part VI, Section B, Line 15 (A) & (B). At the annual convention the stipends for the president and treasurer are included in the
budget presented for approval of the board and convention delegates. The treasurer prepares a proposed budget and presents to the board
at the pre-convention board meeting. The board reviews the budget, line by line, and votes on a recommended budget to be presented
at the convention. The board and delegates of the convention review the recommended budget, line by line, and approve the final budget
by voting. The recommended budget and/or the approved budget may have a different amount than the proposed budget.
Currently the president receives \$350/month stipend and the treasurer receives \$250/month stipend.

Stipends were last raised in the FY2008 budget (July 2007) from \$300/month for president and \$200/month for treasurer. The union does not
have a CEO, Executive Director, or top management official.

The president and treasurer are NOT allowed to vote or be delegates at the convention.
