WE ARE LEADERS OF THE COALITION FOR MORE RESPONSIBLE TRANSPORTATION AND WORK ACROSS THE STATE HOLDING FORUMS AND GATHERING STORIES TO BUILD OUR CASE FOR EQUITABLE AND AFFORDABLE PUBLIC TRANSPORTATION. WE CONTINUE OUR WORK TO STOP WASTEFUL HIGHWAY EXPANSION AND PROMOTE FIXING LOCAL ROADS FIRST.

IT IS AN ALTERNATIVE TO STANDARD "GRAY" INFRASTRUCTURE, WHICH DIVERTS RUNOFF DIRECTLY INTO LOCAL WATERWAYS THROUGH STORM-WATER PIPES AND DRAINS. EXCESSIVE POLLUTION AND NUTRIENT LOADING ASSOCIATED WITH RUNOFF ARE MAJOR PROBLEMS FACING WATERWAYS AND DRINKING WATER SOURCES ACROSS WISCONSIN.
