WITH AN EMPHASIS ON DEVELOPING TRANSIT CONNECTIONS, WE HELP RESIDENTS REDUCIE THEIR DEPENDENCE ON CARS WHILE REDUCING GREENHOUSE GAS EMISSIONS CREATING A HEALTHIER ENVIRONMENT. WE CONTINUED OUR WORK PROMOTING STATEWIDE TRANSPORTATION POLICY THAT USES "FIX IT FIRST" METHODS RATHER THAN WASTEFUL HIGHWAY EXPANSION RESULTING IN A MORE EQUITABLE, ACCESSIBLE TRANSIT SYSTEM. WE ARE LEADERS OF THE COALITION FOR MORE RESPONSIBLE TRANSPORTATION THAT WORKS ACROSS THE STATE HOLDING FORUMS AND GATHERING STORIES TO BUILD OUR CASE FOR EQUITABLE AND AFFORDABLE PUBLIC TRANSPORTATION. OUR ACTIVE WISCONSIN PROGRAM PROMOTES BIKE, PED AND ROLLING INFRASTRUCTURE. THIS IS THE KEY TO HEALTHY COMMUNITIES, FEWER GREENHOUSE GAS EMISSIONS, AND ACCESS BEYOND JUST MOTOR VEHICLES.
