THE INSTITUTE OFFERS ENGLISH CLASSES, RANGING FROM PRE-LITERATE THROUGH COLLEGE PREPARATION AND SUPPORT, AND THEREFORE, IS IDEALLY SITUATED TO SUPPORT NEW AMERICANS AT EVERY SKILL LEVEL.
