IN 2021, THE AGENCY SERVED OVER 11,100 DIVERSE LOW-INCOME INDIVIDUALS IN THE REFUGEE, IMMIGRANT AND BLACK, INDIGENOUS, PEOPLE OF COLOR (BIPOC) COMMUNITIES. 60% OF OUR CLIENTS ARE ASIAN AMERICAN PACIFIC ISLANDERS (AAPI), 95% ARE REFUGEES, IMMIGRANTS, PEOPLE OF COLOR AND 80% OF PARTICIPANTS IN THE ORGANIZATION'S PROGRAMS ARE BELOW THE FEDERAL POVERTY GUIDELINES. THE ORGANIZATION MOBILIZES 48 FULL-TIME EQUIVALENT DIVERSE STAFF (75% STAFF OF COLOR; 75% MULTILINGUAL), MORE THAN 15 DIFFERENT SUB-GRANTED PARTNERS, 3 TENANT AGENCY PARTNERS AND 303-PLUS VOLUNTEERS TO ADVANCE THE SOCIAL AND ECONOMIC POSITION OF MORE THAN 11,100 DIVERSE PEOPLE ANNUALLY VIA THE ORGANIZATION'S THREE CORE PILLARS OF SERVICE INCLUDE: BASIC NEEDS: THE ORGANIZATION'S BASIC NEED PROGRAM HELPED INDIVIDUALS ACCESS A MULTITUDE OF PROGRAMS AND SERVICES TO EXPAND PUBLIC BENEFITS AND RESOURCES. THE PROGRAM SERVED ABOUT 10,000 INDIVIDUALS IN MANY PROGRAMS. THE ORGANIZATION'S CULTURALLY SPECIFIC FOOD SHELF REMAINED OPEN AND PIVOTED TO A CURBSIDE SERVICE SERVING MORE THAN DOUBLE THE NUMBER OF PEOPLE IN 2021.
