TAKEACTION MINNESOTA EDUCATION FUND IS AN ALLIANCE OF INSTITUTIONS AND INDIVIDUALS WHO COME TOGETHER TO BUILD THE POWER OF DIVERSE PEOPLE, COMMUNITIES, AND ORGANIZATIONS IN ACTIVE GRASSROOTS DEMOCRACY THAT ADVANCES RACIAL, SOCIAL, AND ECONOMIC JUSTICE. WE WORK TOWARD A STATE THAT RECOGNIZES THE INHERENT WORTH AND DIGNITY OF EVERY PERSON, AND WHOSE GOVERNMENT AND ECONOMY OPERATE BY US AND FOR US.
