OUR RESEARCH AND POLICY STRATEGY CONNECTS THE POWERFUL TOOLS OF INFORMATION, RESEARCH, AND ANALYSIS WITH THE WORK OF COMMUNITY ORGANIZERS, ACTIVISTS, AND CHANGE-MAKERS.
