LEADERSHIP DEVELOPMENT, TRAINING AND CAPACITY BUILDING IS THE CORE STRATEGY OF ISAAH TO ADVANCE PUBLIC CAMPAIGNS TO SHIFT PUBLIC OPINION AND TO ADVANCE POLICIES FOR RACIAL AND ECONOMIC JUSTICE IN MINNESOTA. PROGRAMS TO DEVELOP THE CAPACITY AND LEADERSHIP OF COMMUNITY-ROOTED INSTITUTIONS LEAD TO THE CREATION OF DISTINCT COALITIONS AND PROGRAMS SUCH AS THE MUSLIM COALITION OF ISAAH; KIDS COUNT ON US (A COALITION OF OVER 500 CHILDCARE CENTERS); ISAAH LEADERSHIP COALITIONS IN SMALL TOWNS AND REGIONAL CENTERS ACROSS CENTRAL AND SOUTHERN MINNESOTA; AND THE BARBERSHOP AND BLACK CONGREGATIONS COOPERATIVE. CIVIC ENGAGEMENT AND PUBLIC CAMPAIGNS: ISAAH PROVIDES STRATEGIC CAPACITIES FOR THE MEMBERS AND COALITIONS CONNECTED TO ISAAH IN ORDER TO EFFECTIVELY DO PUBLIC CAMPAIGNS DEFINED BY THE MEMBERS OF THE ORGANIZATION. ISAAH DEVELOPS POLICY AND RESEARCH, STRATEGIC COMMUNICATIONS, DIGITAL AND ONLINE ORGANIZING CAPACITY, DATA TRACKING AND TOOLS FOR SCALED CIVIC ENGAGEMENT. THE STRATEGIC CAPACITIES OF THE ORGANIZATION ARE DEPLOYED IN THE SERVICE OF CONTINUED PUBLIC DEVELOPMENT OF GRASSROOTS LEADERSHIP FOR RACIAL AND ECONOMIC JUSTICE IN MINNESOTA. MIDWEST COLLABORATIVE FOR TRAINING AND CAPACITY BUILDING: MUSLIM COALITION OF ISAAH AND ENDING ISLAMOPHOBIA: THE MUSLIM COALITION OF ISAAH IS A NETWORK OF 24 MOSQUES AND MUSLIM ORGANIZATIONS THAT WORK COLLECTIVELY TO ADVANCE MUSLIM PUBLIC LEADERSHIP, CHANGE THE NARRATIVE ABOUT MUSLIMS IN MINNESOTA AND WORK TOWARD ENSURING CIVIL RIGHTS FOR MUSLIMS IN MINNESOTA. ISAAH SUPPORTS THE STEERING TEAM AND LEADERSHIP TEAMS OF THE MUSLIM COALITION THROUGH TRAINING, CAPACITY BUILDING, STRATEGIC COMMUNICATIONS, POLICY DEVELOPMENT AND STRATEGIC CAMPAIGNS. KIDS COUNT ON US CAMPAIGN AND CHILDCARE: KIDS COUNT ON US IS A COALITION OF 512 COMMUNITY-BASED CHILDCARE CENTERS THAT SERVE LOW INCOME FAMILIES ACROSS MINNESOTA. KCOU IS LED BY A STEERING COMMITTEE OF EARLY CHILDHOOD EDUCATORS AND WORKERS, PARENTS, AND CHILDCARE CENTER DIRECTORS AND OWNERS. ISAAH SUPPORTS THE KCOU CAMPAIGN THROUGH TRAINING AND CAPACITY-BUILDING, STRATEGIC COMMUNICATIONS AND RESEARCHING AND DEVELOPING POLICY CAMPAIGNS TO INCREASE SUPPORT FOR AFFORDABLE CHILDCARE FOR LOW AND MIDDLE INCOME FAMILIES. STAFF OF KCOU ALSO WORK WITH CHILDCARE CENTERS TO ENSURE THAT STATE REGULATORY AGENCIES ARE SUPPORTING CULTURALLY COMPETENT, COMMUNITY-RUN, LOCALLY OWNED CHILDCARE CENTERS. BARBERSHOP AND BLACK CONGREGATIONS COLLABORATIVE: THE BBCC IS A COALITION OF BLACK OWNED BARBERSHOPS AND CONGREGATIONS IN BROOKLYN PARK, BROOKLYN CENTER, AND NORTH MINNEAPOLIS WORKING TO BUILD THE PUBLIC VOICE AND ENGAGEMENT OF AFRICAN AMERICAN AND AFRICAN IMMIGRANTS. BBCC FACILITATES REGULAR TRAININGS, PUBLIC FORUMS, PUBLIC EDUCATION AND CIVIC ENGAGEMENT THROUGH BARBERSHOPS AND CONGREGATIONS. BBCC IS WORKING COLLECTIVELY ON TENANTS' RIGHTS, AFFORDABLE HOUSING, RESTORING THE VOTE FOR FORMERLY INCARCERATED PEOPLE, TRANSFORMING PUBLIC SAFETY, AND CRIMINAL JUSTICE REFORM. BUILDING AN INCLUSIVE ECONOMY: A SHARED PROJECT ACROSS ISAAH IS TO BUILD AN ECONOMY THAT WORKS FOR ALL OF MINNESOTA'S FAMILIES. ISAAH IS WORKING TO ADVANCE PAID FAMILY AND MEDICAL LEAVE, AFFORDABLE CHILDCARE, EXPANDING PUBLIC HEALTH CARE AND AFFORDABLE HOUSING AT THE STATE LEVEL. ISAAH CONDUCTS SCALED PUBLIC EDUCATION FOR ITS MEMBERS ON THESE ISSUES, CREATES COMMUNITY CONVERSATIONS, ENGAGES WITH POLICY MAKERS, TRAINS MEMBERS TO ENGAGE WITH LOCAL PRESS AND MEDIA, PARTICIPATES IN COALITIONS WITH PARTNER ORGANIZATIONS AND CREATES ONGOING OPPORTUNITIES FOR ISAAH MEMBERS TO HAVE A PUBLIC VOICES ON THESE ISSUES AT THE STATE, REGIONAL AND LOCAL LEVEL. 100% CLEAN ENERGY AND ADDRESSING CLIMATE CHANGE: ISAAH IS A CORE MEMBER OF A STATE-WIDE CAMPAIGN TO GET MINNESOTA TO 100% CLEAN AND RENEWABLE ENERGY. ISAAH HAS LAUNCHED A STATE-WIDE PUBLIC EDUCATION DRIVE TO ABOUT CLIMATE CHANGE AND WHAT MINNESOTANS CAN DO TOGETHER TO MOVE TOWARD BEING A 100% CLEAN ENERGY STATE. THE GOALS OF THE PROJECT ARE TO PASS LEGISLATIVE REFORMS IN 2023 THAT PROTECT AND STRENGTHEN DEMOCRACY, SUCH AS AUTOMATIC VOTER REGISTRATION, RESTORING THE RIGHT TO VOTE TO PEOPLE WITH FELONIES, MODERNIZING ELECTION EQUIPMENT, PRE-REGISTRATION OF 16- AND 17-YEAR-OLDS, ADDITIONALLY, WE AIM TO BUILD PUBLIC AND DECISION-MAKER SUPPORT FOR DEMOCRACY. THIS IS A MASSIVE AND LONG-TERM GOAL, WHICH INCLUDES (A) SHAPING PUBLIC OPINION THROUGH STRATEGIC COMMUNICATIONS; (B) GIVING MORE PEOPLE FIRST-HAND EXPERIENCE OF DEMOCRACY IN ACTION THROUGH PARTICIPATION IN PUBLIC LIFE; AND (C) CONNECTING DEMOCRACY IN THE PUBLIC EYE TO MORE TANGIBLE CHANGES LIKE LIVING WAGES, POLICE ACCOUNTABILITY, AND HOUSING SECURITY.
