GENERAL PROGRAM, STATE, AND FEDERAL POLICY: NCTE'S POLICY AND PROGRAMMATIC WORK ENCOURAGES THE ADOPTION AND IMPLEMENTATION OF TRANS-INCLUSIVE POLICIES AND PRACTICES AT EVERY LEVEL OF GOVERNMENT. AT THE FEDERAL LEVEL, NCTE WORKS TO PROTECT THE RIGHTS OF TRANSGENDER PEOPLE IN ALL AREAS OF LIFE INCLUDING ACCESS TO HEALTHCARE, HOUSING, AND EMPLOYMENT WHILE ENSURING TRANSGENDER PEOPLE ARE TREATED WITH RESPECT IN SCHOOL, PRISONS, BY TSA, AND IN THE MILITARY. NCTE WORKS TO CHANGE ADMINISTRATIVE POLICIES REGARDING IDENTITY DOCUMENTS, FAIR TREATMENT, AND HEALTH CARE AT THE STATE LEVEL. THESE CHANGES REDUCE DISCRIMINATION BY STATE GOVERNMENTS, AND INCREASE ACCESS TO ACCURATE DRIVER'S LICENSE, BIRTH CERTIFICATE RECORDS, AND GENDER-TRANSITION RELATED HEALTH CARE. NCTE PROVIDES RESOURCES AND NON-LEGAL SUPPORT TO TRANS PEOPLE CHANGING THEIR NAME AND/OR GENDER ON IDENTITY DOCUMENTS.

NCTE SURVEYS TRANSGENDER PEOPLE FROM ALL 50 STATES, THE DISTRICT OF COLUMBIA, AND SEVERAL TERRITORIES. THE FINDINGS CLEARLY DEMONSTRATE PATTERNS OF MISTREATMENT AND DISCRIMINATION AGAINST TRANS PEOPLE AND PROVIDES A TOOL FOR PUBLIC UNDERSTANDING AS WELL AS FOR ADVOCATES TO EDUCATE THEIR FEDERAL, STATE AND LOCAL POLICYMAKERS.
