IT ACCOMPLISHES THESE OBJECTIVES THROUGH LITIGATION AND LEGAL ADVOCACY AS WELL AS THROUGH PUBLIC EDUCATION AND OUTREACH ALL DONE TO SECURE AND ADVANCE THE CIVIL LIBERTIES VALUES WHICH ARE REFLECTED IN THOSE AND OTHER AMENDMENTS AND PROVISIONS OF THE CONSTITUTION

LEGAL PROGRAM SERVICES: FILED LAWSUIT THAT SUCCEEDED IN TEMPORARILY BLOCKING ENFORCEMENT OF STATE LAW PROHIBITING SCHOOLS FROM REQUIRING MASKS IN ORDER TO PROTECT CHILDREN WITH DISABILITIES AND UNDERLYING CONDITIONS PUTTING THEM AT HIGHER RISK OF SEVERE ILLNESS, HOSPITALIZATION, AND DEATH FROM COVID-19.
