On-line Education: Dancing Rabbit hosts various courses each year in sustainable living, offering a venue and organizing teachers and course design. In 2020, due to the Covid-19 pandemic, courses normally hosted on-site were cancelled. Energy was shifted towards improving and expanding our on-line educational offerings. We offered a series of webinars on ecological living and a virtual immersive visitor program to allow attendees to experience what life at an ecovillage is like from the comfort of their own home. The virtual visitor program included workshops on a wide variety of sustainable living practices, including: natural and green construction techniques, renewable energy options and practices, inner sustainability and communication skills, decision-making and governance, and more.

4b (Code:) (Expenses \$ **817** including grants of \$ **0**) (Revenue \$ **1,187**)

Project Sponsorship: Dancing Rabbit prioritizes the consideration of sustainability in all manner of choices, including end of life and interment. To this end, we sponsored two local residents (one who builds caskets out of reclaimed pallet wood and another who sews shrouds) to sell these products to our online audience. These products align with our ethic of living lightly and offer an alternative to expensive and highly unsustainable caskets traditionally offered by funeral homes. Additionally, we sponsored a local woman to teach virtual classes to our online audience on BodyTalk, a holistic approach to healing which helps synchronize the body's natural functions.

Research and Community Mentorship: Research is one of the ways we lend credibility to the positive consequences of sustainable living, and in 2020 we hosted a research intern at Dancing Rabbit for the purposes of performing a social audit. This intern conducted interviews and surveys to gather information on the various social systems and structures in operation at Dancing Rabbit Ecovillage in order to assess how well each is achieving its purpose. This research can in turn be used in improving our own systems as well as the education and mentorship of other intentional communities. Dancing Rabbit is often asked for advice and tips for success from other forming intentional communities, and we consider this to be a specific form of education that we can provide based on our 23 years of experience. In 2020, we offered community formation education and mentorship to a group called the Twin Cities Ecovillage project. The group reached out to us wanting more in depth information about the various legal aspects and considerations of setting up a community, and we arranged and offered this to them via Zoom.
