Sustainable Living Visitor Program: The organization hosts several visitor sessions that run each year for two-week durations, that allow individuals to experience the reality of life in an ecological intentional community. Participants attend workshops on a wide variety of sustainable living practices such as natural and green construction techniques, permaculture and renewable energy production.

On-Farm Education: The organization hosts various courses each year in sustainable living, offering a venue and organizing teachers and course design. Participants learn and practice methods of natural building while getting exposure to an ecologically-friendly lifestyle.

Eco-Village Tours / Short Term Visitors: The organization offers several options for the public to see examples of functioning sustainable lifestyles. This is achieved through offering short tours of homes and communal facilities, hosting participants for one to three days, and offering a large open-house weekend event. Participants are able to see alternative building methods, organic gardens, renewable energy, water catchment, etc.
