Greater Kansas City Coalition to End Homelessness (GKCCEH) leads a coordinated community response to prevent and end homelessness by managing the region's HUD Continuum of Care (CoC) funding and strengthening the local homeless response system. We facilitate the annual CoC funding competition and provide oversight, monitoring, and technical assistance to local service providers to ensure federal resources are used effectively to deliver housing and supportive services for individuals and families experiencing homelessness. GKCCEH also supports the development of new programs and initiatives to address service gaps, uses data to guide system improvements, and collaborates with nonprofit and government partners to expand access to stable housing and improve outcomes for vulnerable households throughout the community.
