THIS WAS DONE THROUGH THE AUWRF, MANY OF THESE FAMILIES OF IMMIGRANTS WITH MIXED STATUS. ADAC LEADERSHIP PARTICIPATED IN SUCCESSFUL EFFORTS TO INCLUDE FAMILIES LIVING IN PHOENIX, IN THE CARES RELIEF FUND, REGARDLESS OF THEIR IMMIGRATION STATUS.
