A TOTAL OF 387 DACA RECIPIENTS RENEWED THEIR PROTECTIONS WITH GUIDANCE FROM THE ORGANIZATION, WHILE 247 DREAMERS OBTAINED ADVANCE PAROLE DOCUMENTS THAT ALLOWED THEM TO TRAVEL INTERNATIONALLY FOR STUDY ABROAD TO MEXICO, PERU AND ITALY IN 7 GROUPS. THE SUENOS MIGRANTES INITIATIVE MADE IT POSSIBLE FOR 6 LONG-SEPARATED FAMILIES TO REUNITE.
