U.S. & Canada Program: GAIA provided technical and strategic support, resources, and information to members and allies in the U.S. and Canada, and amplified their efforts via social media, as they worked to address pressing waste issues in their communities. Our project From Dumping Grounds to Healthy Communities provided focused, ongoing support to local organizations in Baltimore, MD; Detroit, MI; Long Beach and Commerce, CA; Minneapolis, MN; Newark, NJ; and Oregon in efforts shut down polluting incinerators and advance healthier alternatives. GAIA launched the U.S. Zero Waste Master Plan, a tool designed to simultaneously support the planning and policymaking side and the organizing and advocacy side of advancing zero waste approaches at the city level, in September 2020. A companion guide for organizers was created to support engaging these two audiences most effectively. These resources were rolled out via a digital series with the NAACP as a featured speaker and local groups invited, as well as social media including a short video and case studies.

International: GAIA uses a movement-building network model that empowers members to build their own capacity, facilitates international solidarity in response to local organizing efforts, and coordinates collective research and campaigns around the issues of waste, pollution, climate and environmental justice. We continue to coordinate various international and regional listservs, reaching our network of member organizations across 93 countries, and we have been advancing our member outreach through new platforms that will enhance the sharing of member experiences and the coordination of cross-regional efforts. We also helped to link our members to expert resources for public events and environmental impact reviews. GAIA supported members around the world in efforts to protect the environment, public health, and human rights by blocking the construction of incinerators in their communities and shifting political and financial drivers away from dirty energy. GAIA responded to growing requests on the proper handling of COVID-19 related waste by hosting webinars throughout the year. We also launched the #BeyondRecovery campaign in early 2021, emphasizing the role of waste workers and zero waste in a post-COVID world. Our Global Day of Action on March 31, 2021, engaged more than 150 groups across the globe in organizing events and campaigns urging leaders to develop recovery policies that would reduce plastic production and consumption. In April 2020, in recognition that frontline waste workers and advocates in communities around the world were continuing to provide critical services at great risk to themselves and their families, GAIA launched an Emergency Solidarity Fund. Over \$200,000 were raised and distributed in Argentina, Bangladesh, Brazil, Chile, Costa Rica, the Democratic Republic of the Congo, Ecuador, El Salvador, Ghana, India, Indonesia, Kenya, Liberia, Nicaragua, Nigeria, Panama, the Philippines, Rwanda, Sierra Leone, South Africa, Tanzania, Uganda, the United States, Uruguay, Vietnam, and Zambia. Funds covered a variety of particular local needs, from providing personal protective equipment to waste pickers, supporting core costs of groups under stress because of the pandemic, delivering community education about COVID to environmentally impacted groups, enabling advocates to shift to digital organizing strategies, and meeting the basic needs of waste workers who were not able to work because of lockdowns. Communications: GAIA maintained our role in the GAIA Global Networks Communications Team, working to amplify regional work globally, to encourage cross-regional collaboration for strategic impact, and to collaborate on global communications campaigns. GAIA's US & Canada communications efforts including launching a monthly newsletter highlighting member stories; engaging members in narrative-building leading up to the Global Day of Action to strengthen stories of members working in solidarity across borders, aligned with the #BeyondRecovery communications campaign, and continuing to grow social media and earned media impact promoting campaigns, publications, and events.

4c (Code:) (Expenses \$ 557,583 including grants of \$ 290,500) (Revenue \$)

Plastic Solutions & Zero Waste Cities: GAIA continued our active leadership role in the global Break Free From Plastic (BFFP) coalition. In Argentina, advocacy by GAIA members led to the reversal of a plastic import decree, which would otherwise have had consequential repercussions undermining BFFPs 2019 victory at the Basel Convention regarding plastic waste trade. GAIA staff have also been providing technical support on how to transpose the Basel Conventions agreement on plastic waste trade into national legislation, engaging in briefings on the topic, identifying pitfalls, and providing a unique civil society perspective in a space dominated by the public and private sectors. With support from our action funds, and one-on-one support from GAIA staff, GAIA/BFFP member groups broke new ground on plastic waste trade research and policy work in their countries, exposing the reality of plastic waste imports and the conditions in which those wastes are recycled, and demanding import bans and greater transparency. GAIA members provided local governments with technical assistance, leading to domestic policy wins. Several cities in the Asia Pacific region, such as Tacloban (Philippines) and Bandung (Indonesia), passed local ordinances that regulate, manage, and reduce single-use plastics (SUPs). We also saw similar developments in Africa including Kenya and Senegal, which imposed stricter measures against SUPs. Despite the challenges of COVID-19 pandemic, GAIA has supported an even deeper commitment to zero waste as a sustainable solution in many of the cities where its members work. GAIA organized a series of regional events throughout the year including, the Trash Heros Zero Waste Communities training was held last October and November 2020 for Thailand, Indonesia, and Malaysia to combine technical and practical knowledge about zero waste that would kick-start sustainable projects in participants own communities. GAIA launched the Zero Waste Academy online in January 2021, a training for waste practitioners, government officials, and NGO leaders to learn more about establishing zero waste systems in their communities. The pilot run for this project has already commenced in the Philippines and will be used as a future model for regional and international audiences. In March 2021, the global Zero Waste and Economic Recovery report was issued to make the case for the economic benefits of investing in zero waste as part of efforts to recover from the economic slowdown that has accompanied the pandemic. Alongside ongoing implementation of zero waste in flagship cities throughout the Asia Pacific region more cities are showing interest in adapting or expanding the model such as Hoi An (Vietnam) and Mumbai (India). This interest has also extended to island communities like Siquijor (Philippines), where we started devising the Zero Waste Island Framework. The City of Trivandrum (India) received a national 2020 City Governance Award for its zero waste efforts. GAIA's Asia Pacific team launched an online learning series about zero waste and leading sustainable lifestyle practices. In Latin America, despite being hard-hit by the pandemic, representatives in the region have been meeting virtually to develop a long-term strategy for expanding zero waste efforts for the region. GAIA members in Argentina, Chile, Ecuador and Mexico developed reports with detained research involving the waste trade situation in their countries as part of global policy advocacy around waste trade and the Basel Convention. We held a two-day workshop and created an information kit on Agroecology, a way to deplasticify food. Our Emergency Solidarity Fund (discussed below) played an especially crucial role in sustaining zero waste cities work in this region in the face COVID-related lockdowns, including supporting information sharing relevant to zero waste ordinances and extended producer responsibility, and leveraging the role of waste pickers and addressing the challenges they face in a post-pandemic world. In Africa, rapid expansion of GAIA and BFFP membership brings together 46 organizations in 21 countries. GAIA members have started zero waste models in Tanzania, Ghana, and South Africa, with financial support from Fondation Nr and the Urban Movement Innovation Fund and technical support from GAIA. With additional support from the Plastic Solutions Fund and the SAGE Fund, efforts are now expanding to other priority countries, including Nigeria and Kenya. In Europe, we worked with our sister organization, Zero Waste Europe, to support zero waste developments. Several new cities in Ukraine, Croatia, and Slovenia have taken significant steps toward zero waste, and the first ever regional State of Zero Waste Municipalities Report was released, providing context for zero waste best practices across Europe through quantitative and qualitative data. The Zero Waste Cities Certification, which is given to municipalities that officially follow a zero waste strategy based on systematically reducing waste, was also launched. Advocacy also pushed the European Parliament to recognize the importance of formulating new initiatives that maximize waste prevention and minimize incineration.

Launched in September 2016, the movement now comprises more than 2,500 organizations across the world and thousands of individual supporters demanding massive reductions in single-use plastics and pushing for lasting solutions to the plastic pollution crisis. BFFP strives to bring systemic change through a holistic approach that tackles plastic pollution across the whole plastics value chain, focusing on prevention rather than cure, and providing effective solutions.Break Free From Plastic (BFFP) U.S.: GAIA continued as fiscal sponsor of the Break Free From Plastic movement of 159 member organizations in the U.S. and Canada working across the plastics value chain for systemic change. This work includes challenging the petrochemical buildout, pushing for corporate accountability, promoting systemic solutions, and building zero waste communities. We have worked to shift the narrative about plastic, change policies, and build a strong, intersectional, and resilient movement, ensuring connections between zero waste strategy and implementation and work addressing plastic pollution. The movement grew its membership by more than 30%, so it now has active members in 33 states, and established a multi-year Strategy Plan, along with an Equity Roadmap developed by BIPOC/Environmental Justice members and incorporated into the workplan as part of our efforts to center environmental justice throughout plastics work. BFFP U.S. & Canada provided 25+ capacity building sessions to members, supported member efforts to engage in policy advocacy, secured significant earned media, amplified the launch of The Story of Plastic, and had strong participation in the annual global brand audit that empowers key corporate campaigning. OTHER PROGRAM SERVICES 5: OTHER PROGRAM SERVICES 6: Global Policy: GAIA has been active in global policy efforts addressing climate and plastics. We are leading a collaboration that draws on local work on zero waste strategies in the Philippines, Brazil, and the U.S. to build the case for zero waste as an important climate strategy that also helps develop and grow local environmental and climate movements. We have been active in efforts at UNEA especially ensure strong Global South participation in work toward a global plastics treaty. Our strategy also includes participating in the UNFCCC COPs, and providing input to scientific reviews being prepared by the IPCC, supporting EU policy work led by our sister organization Zero Waste Europe, as well as developing a case-building set of publications. Our work on plastics policy, in the context of the global Break Free From Plastics work, included completing a sophisticated gap analysis of global policy spaces, pushing back against an OECD loophole that could undermine the Basel Conventions rules on plastic waste dumping, initiating efforts to have the IPCC address plastic as a climate issue, had a positive impact on the framing of the Pew Charitable Trusts high-profile study on plastic inputs to the ocean, and educated and advocated internationally on chemical recycling as a false solution.
