International: GAIA uses a movement-building network model that empowers members to build their own capacity, facilitates international solidarity in response to local organizing efforts, and coordinates collective research and campaigns around the issues of waste, pollution, climate and environmental justice. We continue to coordinate various international and regional listservs, reaching a substantial number of our network of nearly 1100 member organizations across 90 countries, and we have been advancing our member outreach through new platforms that will enhance the sharing of member experiences and the coordination of cross-regional efforts. We also helped to link our members to expert resources for public events and environmental impact reviews. GAIA supported members around the world in efforts to protect the environment, public health, and human rights by blocking the construction of incinerators in their communities and shifting political and financial drivers away from dirty energy. GAIA’s Emergency Solidarity Fund, launched during the pandemic to address the small organizations and waste picker groups hard hit by the impacts of COVID, continued to distribute nearly \$200,000 in small grant funding to communities in need over the past year.

U.S. & Canada: GAIA provided technical and strategic support, resources, and information to members and allies in the U.S. and Canada and amplified their efforts via social media, as they worked to address pressing waste issues in their communities. Our project From Dumping Grounds to Healthy Communities provided focused, ongoing support to local organizations in Baltimore, MD; Detroit, MI; Long Beach and Commerce, CA; Minneapolis, MN; Newark, NJ; and Oregon in efforts to shut down polluting incinerators and advance healthier alternatives. As part of our proactive strategy to shut down aging incinerators in areas where these facilities are predominant, we published the report A Tale of Five Cities, examining successful municipal recycling programs in five U.S. cities. Multiple webinars on zero waste, incineration, and the plastic waste trade were held throughout the year to accommodate growing requests both by GAIA members and the communities they serve.

Break Free From Plastic Global: BFFP, a fiscally-sponsored project of GAIA, is a global movement envisioning a future free from plastic pollution. Launched in September 2016, the movement now comprises more than 2,500 organizations across the world and thousands of individual supporters demanding massive reductions in single-use plastics and pushing for lasting solutions to the plastic pollution crisis. BFFP strives to bring systemic change through a holistic approach that tackles plastic pollution across the whole plastics value chain, focusing on prevention rather than cure, and providing effective solutions.

The United Nations Environmental Assembly has officially adopted a mandate to begin negotiations for a legally binding treaty addressing the full life cycle of plastic, from production to disposal. As recently as just a few years ago, saying we would arrive at a win like this in 2022 would have come as a shock to everyone, and this victory is a testament to movement-building and the groundswell of support from the countries where many of our members work. Along with environmental activists, scientists, and grassroots organizations around the world, GAIAs relentless advocacy efforts helped push for the treaty. Supplying stories for major media outlets like VICE and Foreign Policy, which compared the potential of the mandate to the successful Montreal Protocol, allowed us to position ourselves as a thought leader in curbing plastics. Local climate efforts are now being embedded in zero waste strategies in multiple cities, including Durban, Dar Es Salaam, and So Paulo, all driven by GAIA members who are receiving financial and technical support from the GAIA team. GAIA has initiated a push with the IPCC that would highlight plastics as a climate change problem for the first time. GAIA also partnered with Changing Markets Foundation and the Environmental Investigation Agency (EIA) to release METHANE MATTERS, a report that sets out the quickest and most effective actions governments can take to deliver on the Global Methane Pledge. OTHER PROGRAM SERVICES 5: Communications: GAIA maintained our role in the GAIA Global Networks Communications Team, working to amplify regional work globally, encourage cross-regional collaboration for strategic impact, and collaborate on global communications campaigns. GAIAs communications efforts included strengthening several awareness campaigns in the past year, including the #BeyondRecovery and #StopWasteColonialism campaigns. During these campaigns, GAIA developed and launched publications, educational videos, and online webinars. These campaigns were so successful that GAIA managed to reach 2 million users on global social media handles and secure over 500 local and international media hits last year. Moreover, GAIA also launched a brand new website with a sleek design that gives online visitors easier access to resources. OTHER PROGRAM SERVICES 6: Break Free From Plastic Global: BFFP, a fiscally-sponsored project of GAIA, is a global movement envisioning a future free from plastic pollution. Launched in September 2016, the movement now comprises more than 2,500 organizations across the world and thousands of individual supporters demanding massive reductions in single-use plastics and pushing for lasting solutions to the plastic pollution crisis. BFFP strives to bring systemic change through a holistic approach that tackles plastic pollution across the whole plastics value chain, focusing on prevention rather than cure, and providing effective solutions. OTHER PROGRAM SERVICES 7: Break Free From Plastic U.S.: GAIA continued as fiscal sponsor of the Break Free From Plastic movement of 159 member organizations in the U.S. and Canada working across the plastics value chain for systemic change. This work includes challenging the petrochemical buildout, pushing for corporate accountability, promoting systemic solutions, and building zero waste communities. We have worked to shift the narrative about plastic, change policies, and build a strong, intersectional, and resilient movement, ensuring connections between zero waste strategy and implementation and work addressing plastic pollution. The movement grew its membership by more than 30%, so it now has active members in 33 states, and established a multi-year Strategy Plan, along with an Equity Roadmap developed by BIPOC/Environmental Justice members and incorporated into the workplan as part of our efforts to center environmental justice throughout plastics work. BFFP U.S. & Canada provided 25+ capacity building sessions to members, supported member efforts to engage in policy advocacy, secured significant earned media, amplified the launch of The Story of Plastic, and had strong participation in the annual global brand audit that empowers key corporate campaigning. OTHER PROGRAM SERVICES 8: The Urban Movement Innovation Funds Convenings Program: GAIA serves as host of UMIFs Convenings Program, which supports coordination of UMIF partner gatherings, provides administrative backstopping to enhance the focus of gatherings, and evaluates meetings for impact. UMIF is a philanthropic initiative that aims to connect, align and strengthen people-power for a zero carbon future by catalyzing commitments in key cities around the world. This independent group supports projects that build power and connect the efforts of NGOs working on technical solutions and climate policy with those of grassroots groups and movements working to increase citizen engagement.
