BASEBUILDING AND CANVASS FOR POWER:CPDA'S CANVASS PROGRAM IS AN INNOVATIVE APPROACH TO BUILDING A DUES-PAYING MEMBERSHIP BASE FOR AFFILIATE ORGANIZATIONS WORKING IN LOW-INCOME COMMUNITIES AND COMMUNITIES OF COLOR THAT IS DEEPLY ENGAGED IN PUSHING FOR PROGRESSIVE LEGISLATION AND CREATING A POLITICAL LANDSCAPE THAT BENEFITS OUR AFFILIATES' MEMBERS. CPDA'S BASEBUILDING PROGRAM PROVIDES DIRECT FIELD CAPACITY TO OUR AFFILIATE ORGANIZATIONS, HELPS THEM BUILD MEMBERSHIP AND LEADERSHIP IN COMMUNITIES MOST IMPACTED BY STRUCTURAL RACISM AND CAPITALISM.
