WE PRIORITIZE WORK THAT FOCUSES ON TAXES, BUDGET, HEALTHCARE, SAFETY NET PROGRAMS, INFRASTRUCTURE, IMMIGRATION, AND FINANCIAL INDUSTRY DEREGULATION. WE ALSO ADDRESS POTENTIAL NOMINATIONS TO HIGH LEVEL POLICY AND JUDICIAL POSITIONS.
