WE EDUCATED THE PUBLIC ABOUT WHAT REPRODUCTIVE HEALTH DECISIONS AT THE SCOTUS LEVEL MEANT FOR NEW MEXICANS, THE MIFE CASE AGAINST THE FDA, AND PROVIDED COMMUNICATIONS SUPPORT FOR REPRODUCTIVE HEALTHCARE PARTNERS.
