WE CONTINUED TO EDUCATE THE PUBLIC ABOUT WHAT REPRODUCTIVE HEALTH DECISIONS AT THE SCOTUS LEVEL MEANT FOR NEW MEXICANS AND PROVIDED COMMUNICATIONS SUPPORT FOR REPRODUCTIVE HEALTHCARE PARTNERS.
